Proposed Intro No. / Title: *Int. 1067 / Assistance program for homeowners experiencing groundwater flooding in the city of New York and a southeast Queens flooding adaptation assistance task force, and to repeal certain such amendments upon the expiration thereof*

Summary of Legislation: The legislation establishes a Southeast Queens Flooding Adaptation Assistance Taskforce which is required to meet at least biannually, convene a public meeting in SE Queens, and submit an annual report of activities and recommendations. It also requires the Department of Environmental Protection to submit an annual report related to groundwater levels and flooding plans and create a flooding adaptation assistance partnership program. Additionally, the Department of Housing Preservation and Development shall develop informational resources about flood-related assistance programs for homeowners administered by federal, state, or city agencies, or by not-for-profit organizations.

Effective Date: 180 days after enactment, except that section four takes effect 270 days after enactment
