Summary of Legislation: This legislation requires the Office to End Domestic and Gender-Based Violence (END-GBV) and the Department of Health and Mental Hygiene (DOHMH) to review all existing city-collected data on gender-based violence and make recommendations to agencies on how to improve data collection practices. END-GBV and DOHMH shall also conduct outreach to healthcare providers to survey gender-based violence screening practices and to assist providers in integrating trauma-informed recovery methods. Additionally, ENDGBV would be required to develop of dashboard for gender-based violence data.

Effective Date: 120 days after enactment

Impact on Expenditures (Expense):

It is anticipated that END-GBV would require \$217,000 in annual Personal Service (PS) resources, including fringe, to add two staff members to collect and analyze data, and to develop the reports.

It is also anticipated that DSS would require \$1,757,000 in annual PS resources, including fringe, to hire 15 social workers and 1 research scientist to assist in data collection, management, and reporting.

Additionally, DSS anticipates requiring \$860,000 in one-time Other Than Personal Service (OTPS) resources in year one to develop the Data Dashboard. In year two and thereafter, DSS would require \$120,000 in annual OTPS for dashboard maintenance.
