Proposed Intro No. / Title: *Int. 1065 / Terms of employment for district managers*

Sponsors: Williams

Committee: Governmental Operations, State & Federal Legislation

Summary of Legislation: This legislation establishes a four-year term limit for community board district managers. The first term would begin on the effective date of the legislation through December 31 of the fourth full calendar year thereafter. The community board or the borough president may reappoint the same individual for successive terms. The bill also allows the community board or the borough president with jurisdiction over the community board to remove the district manager before the end of their term. Additionally, it clarifies that a member of a community board may be appointed as district manager, provided they do not participate in any part of the selection process and resign from the board prior to or upon assuming the role of district manager.

Effective Date: Immediately upon enactment
