**Summary of Legislation:** This legislation requires that the Department of Health and Mental Hygiene (DOHMH) inspect buildings for rodents within 14 days of receiving a relevant 311 service request or complaint. The legislation further requires that DOHMH collect a variety of information during the inspection including location, inspection result, and whether a notice of violation or order to abate was issued. DOHMH would be required to post said information online within 30 days of the inspection's completion.

**Effective Date:** Immediately upon enactment
