Daneek 5 Miller, Chair of the Committee on Civil Service and 6 Labor, and today we'll be voting on Intro 1785, Introduction 1785 introduced by myself as a local law 8 that would extend health insurance coverage to the 9 surviving spouses and children of any New York City 10 Municipal employee that is killed while performing 11 there or where that employee developed a health 12 condition as a result of their response to 9/11 13 rescue, recovery and cleanup efforts at the World 14 Trade Center and other impacted areas. Currently, 15 the law allows health benefits to surviving benefit 16 members of uniformed New York City municipal 17 employees. Those outside the uniform services who 18 die in the line of duty can also have health benefits 19 extended to their surviving benefits-to their 20 surviving spouses, but only in case by case basis. 21 Introduction 1785 ends this practice, and provides 2.2 equity to all families of New York City workers. 23 Introduction 17 85 also recognizes that the heroic 24 efforts of New York City workers who answered the 25 call in 9/11 in the months that followed, those

3	city will take care of their beloved—their loved
4	ones, and in the—in the event of their untimely
5	passing. This is one of the most important bill this
6	committee can pass this legislative session, and this

9	servants who add value to our city each and every
10	day. I'm proud to sponsor this legislation, and look
11	forward to its passage. I would like to thank
