Dear Councilmember Sanchez,

I am proud to submit this testimony in support of the Kingsbridge Armory Redevelopment project's Land Use-related application(s).

For decades, the Kingsbridge Armory site stood as a dispiriting exhibit of political inaction, broken promises, and bureaucratic blockage. I was proud to collaborate with your office, our state and local partners, community leaders, and my colleagues in the United States Congress to secure \$215 million in government funds for its redevelopment. This project will significantly enhance the Kingsbridge neighborhood and deliver vital community space, local jobs, and economic growth to the area -- and to the Bronx at large.

The vibrant, mixed-used development project will include 450 units of affordable rental housing units on an adjacent site and 25,000 square-feet of dedicated community space, which will be utilized for educational and workforce development programming. The project will also bring new sports and recreation activities for Bronx youth.

This redevelopment project, which enjoys overwhelming support from community leaders and elected officials, is expected to generate more than \$2.5 billion in economic impact over the next 30 years -- and will rely on many permanent employees, who will largely be members of the surrounding community. In the immediate future, it will create 3,000 local construction jobs, which will boost the economic output of the surrounding small businesses. When completed, the Kingsbridge Armory Redevelopment site will no longer be a sign of government failure or stand as a black eye on the Kingsbridge community -- but will instead represent that vibrance and promise of the Bronx and the power of the community's advocacy efforts. Likewise, as demonstrated by other major redevelopment projects around New York City in recent years, the completion of this project is likely to spur additional, synergistic investments in affordable housing, small businesses, and common spaces within the Bronx and Kingsbridge neighborhood.

Accordingly, I respectfully reiterate my support for the Kingsbridge Armory Redevelopment's applications associated with the Land Use process and permitting requirements. I commend you, your staff, our partners, and the development team for contributing to this vital project.

# Senator Gustavo Rivera's Testimony on the Kingsbridge Armory Redevelopment to the New York City Council Subcommittee on Landmarks, Public Sitings, And Dispositions

Tuesday, September 30, 2025

Thank you, Acting Chairwoman Nurse, for allowing me to share a few words at this hearing. My name is Gustavo Rivera, State Senator for the 33rd District in the Northwest Bronx. I am here today to voice my strong support for the Kingsbridge Armory Redevelopment Project by 8th Regiment Partners.

I want to thank my colleague, Councilmember Pierina Sanchez, for her staunch advocacy for our community. Above all, thank you to my neighbors who demanded opportunities for public input ahead of the ULURP process, through the Together For Kingsbridge Visioning Process that shaped the request for proposals and the selection of the developer.

When I was first elected in 2010, the Armory was part of my district and just two blocks away from where I lived. After the 2023 redistricting, the Armory now sits just across the street from my current Senate District. As their representative, I remain accountable to tens of thousands of Bronxites who deserve to benefit from the Armory's redevelopment. As we near the end of the ULURP process, the aspirations, needs, and concerns of our community must be central to the project's priorities and approval.

We expect this developer to commit to an even stronger Community Benefits Agreement (CBA) than the nationally-renowned agreement that our community won during the previous redevelopment. The previous cba should be considered the standard because it included:

- Local hiring, training, and living wages
- Permanent union jobs
- Sustainability standards
- Community space
- A community benefit fund that dedicates at least 1% of project gross revenues for wealth-building in the Bronx
- Community governance and oversight

The community is expecting more from this development:

- True community ownership. Thank you to the Northwest Bronx Community and Clergy Coalition for securing a Memorandum of Understanding to ensure the manufacturing space is owned and operated by our community.
- Local procurement for our small businesses
- Union jobs for the construction of the Armory, to address the flooded basement and the hole in the roof
- Ensuring local street vendors can continue to make a living

• Multi-bedroom units as part of the affordable housing plan, even if that means less units overall. Those apartments should be for current residents.

We expect the New York City Economic Development Corporation (EDC) to offer a lease agreement that truly benefits the Bronx. After 30 years of passive neglect, the costs of mitigation have ballooned, and the developer will need to spend tens of millions of dollars simply to get the site construction ready. The Bronx receives less services, less funding, and less investment than anywhere else, so the EDC must recognize that this project is a chance at redemption.

I am urging EDC to finalize an agreement where the City breaks even so that the developer and their partners can keep as much revenue as possible for the community fund, union labor, youth and community programming, and other local benefits. This is not a project that should be on EDC's books as a boon to city coffers. The Bronx is owed investment, and the Armory is our chance to get what we are owed. We expect the city to commit to revitalizing our community through:

- Strong anti-displacement measures to protect local businesses, including capital funding access through both loans and grants, legal support, and financial coaching
- Dedicated City and State Opioid Settlement Fund dollars to support community health and safety in the blocks surrounding the Armory, through service delivery, syringe clean up and exchange, and facilities to support these efforts
- Supporting a robust Community Revenue Fund instead of the Citywide public purse

The \$200 million investment from the State and City is just a start. The community has been waiting for 30 years for the Armory to put us on the map, but not at the expense of those waiting 30 years to see it transform. This redevelopment project must be for the Bronx and no one else.

I have worked for years to ensure that our borough sees the benefit from a transformative redevelopment. Time and time again, we have seen only a small percentage of people benefitting from projects like this, leaving out local communities, including small business owners. This cannot happen to our Kingsbridge community.

I will continue to support our community and key stakeholders to ensure this project fulfills its potential, and I will not be afraid to hold anyone accountable for any decisions that do not prioritize our neighbors first. I will have my community behind me to hold all parties accountable.

I've been here through three mayors, two borough presidents, two council members, and two governors, and I'll be here for the ribbon cutting to enjoy this space with my neighbors.

Christina Callender's Testimony for Kingsbridge Armory Redevelopment

Hello Council,

My name is Christina Callender, and I am from Kingsbridge and a soon-to-be graduate of the nearby Lehman College and have been engaged with this project through NWBCC. I've dedicated my studies and professional life to understanding and alleviating the strains on working-class communities much like the one I'm from.

I'm deeply invested in projects that not only enhance economic prosperity but also improve the lives of the people who live here now. I'm in strong support for this project, however we have the opportunity to ensure that the current project is one that keeps its benefits rooted in The Bronx and a different model of development is exemplified through key efforts. To achieve that, I urge the commitment to a community benefits agreement and for the City and the Developer to commit to the following:

Firstly, there must be an accessible design. The Armory must be welcoming and usable for all residents, including those with disabilities. That means ramps, lifts, wide pathways, and clear signage designed in partnership with the disability community.

Secondly, the project must ensure truly affordable, family-sized housing that prioritizes Bronx residents in leasing. This project cannot rely on inflated AMI. so there must be some measures to counteract this to ensure that "affordability" reflects Bronx incomes, so families here can actually qualify. Units must include two- and three-bedrooms.

Thirdly, the project must emphasize local hiring and contracting. This means that jobs at every stage must go to Bronx residents, and businesses first. Contracts should be awarded to Bronx-based businesses, MWBEs, and worker cooperatives. Additionally, space needs to be made available for existing Bronx vendors to mitigate displacement and ensure that wealth circulates within our borough.

Fourthly, affordable community access to Armory uses should be prioritized. Create pricing and access policies that lower financial barriers for Bronx residents: e.g., resident discounts, sliding-scale memberships, free community hours, and no-cost space allotments for youth, seniors, and local nonprofits so the people who live here can actually benefit from what's inside.

Lastly, the city must ensure that the public infrastructure surrounding the armory matches the

Armory's project's scale. The armory will draw thousands of people and the city must meet the demand. This could be done with increased bus service on the BX9 and BX22, expanded 4, B, & D train service, and safety officers to guide traffic and pedestrians during large events. The surrounding area also needs stronger sanitation services; more frequent pickup, public trash cans, and recycling bins, so the Armory remains an asset, not a burden, to the neighborhood.

This project has the potential to set a new standard for equitable development in New York City, but this will only happen if the project commits to a signed community benefits agreement and holds Bronx residents at the center.

Thank you Christina Callender Christina Callender Good morning, my name is Osei Dwomoh, a Sophomore at Lehman College, and a member of the Northwest Bronx. As a native Bronx resident for almost 20 years, I've seen changes in my area, and the decisions we make in the long term would have an impact for years, if not decades, to come. Right now, our community needs help, economically and mentally. To give them a place that can let them shop, let them grow, and let them build stability, and this borough stability. If the Bay Plaza Mall provided these possibilities with just a bus ride away, I figured we could do the same thing here. If we want to reduce unemployment and the unhoused, we have to lay the groundwork. We've been living here since we came here. Let's live with peace of mind. Thank you for listening and understanding.

Good morning, Chair **Kamillah M. Hanks**, members of the Subcommittee, and community stakeholders. My name is **David Levers**, and I serve as the **Director of Government Relations and External Affairs at Bronx Community College**, where I am a member of the President's Cabinet. It is my privilege to testify today in strong support of the **Kingsbridge Armory Community Benefits Agreement (CBA).** 

At Bronx Community College, our mission is to advance **equity, inclusion, and public higher education** as pathways to opportunity. The redevelopment of the Kingsbridge Armory is a once-in-a-generation project, and we believe it must be anchored in a clear commitment to the people of the Bronx through a strong, enforceable CBA.

#### **Opportunities for Youth**

For our students, and for the young people of the Bronx, this project must create meaningful opportunities. We are encouraged that the CBA includes:

- Youth internships connected to Armory tenants and vendors;
- Job training, workforce development, certification programs, and apprenticeships that prepare Bronx residents for lasting careers; and
- **Partnerships with local colleges**, including Bronx Community College, to design direct pipelines from education into the workforce.

These commitments should be **legally binding** within the Community Benefits Agreement to ensure accountability. Bronx Community College is ready to partner with the Armory and its tenants to shape these programs and deliver real results for Bronx families.

#### **Investments in the Surrounding Neighborhood**

The reality is that the Bronx continues to live with the effects of **decades of disinvestment.** A project of this magnitude has the power to reverse that history, but only if the surrounding neighborhoods are also given the resources they need to succeed.




#### That means:


- Supporting small businesses facing the risk of displacement;
- Investing in **public parks** that are still waiting for long-overdue improvements; and
- Rehabilitating **housing** that remains in urgent need of repair.

The City must pair this redevelopment with **robust, visible investments in the Bronx** to ensure the Armory benefits not only those within its walls, but the community as a whole.

In closing, Bronx Community College proudly supports this Community Benefits Agreement because it reflects our mission and values — and because we know that when the Bronx is given opportunity, it thrives. This redevelopment has the potential to be a landmark investment not just in a building, but in the people of the Bronx.

Thank you, Chair Hanks, and thank you to the Subcommittee for your leadership. I look forward to continuing this partnership and to answering any questions you may have.



Good Afternoon City Council,

My name is Brenida Parsons, and I am a proud resident of this Bronx neighborhood for over 40 years. I currently serve on the NYCPS Panel for Educational Policy (PEP) Bronx Representative, and I've had the honor of being a Community Education Council (CEC) District 10 president for two years. I am writing this testimony on behalf of myself, as a parent, as an advocate, as a neighbor, and someone deeply invested in the future of our community.

The redevelopment of the Kingsbridge Armory represents a historic opportunity. One that must reflect the needs, dreams, and potential of the Bronx. I am calling on City Council and development stakeholders to ensure that this project becomes a beacon of education, opportunity, and equity for our youth.

I'm proposing a three-part community initiative to be embedded in the Armory redevelopment:

# 1. Youth Employment Empowerment – For All Students, Including Those with Special Needs and our English Language Learners.

A section of the Kingsbridge Armory should cater to a center for career and technical training. I'm proposing year-round internship and externship programs that provide first-priority access for Bronx District 10 school community students, including students with special needs. These should connect directly to union trade careers and skilled professions in:

- Environmental studies
- Historical and contextual studies.
- Architecture
- Carpentry
- Plumbing
- Electrical
- Masonry

These programs must also include expanded STEM education and college-prep courses, in partnership with our nearby CUNY colleges, that lead to industry-recognized certificates or degrees.

Additionally, I propose that the Summer Youth Employment Program (SYEP) be extended into the school year, creating a continuous pipeline from classroom to career.

#### 2. Generational Economic Wealth & Transitional Support

Empowerment must go beyond employment. The Armory should house a financial literacy and economic empowerment center offering:

- Courses in opening bank accounts, building credit, and managing finances
- Introductory training in real estate, investment banking, and entrepreneurship
- Access to certification programs through accredited institutions

And for our high school seniors heading to college, I propose guaranteed transitional housing opportunities—because no student should have to choose between education and shelter.

#### 3. Civic Engagement & Leadership Opportunities for Students

Lastly, I urge you to include programming that brings students into the civic life of our borough. The Armory should host:

- Civic education workshops with our schools
- Youth mentorship programs with our elected Bronx leaders
- Opportunities for students to participate in future community board meetings and public hearings at the Armory.
- A dedicated Youth Advisory Council to keep young voices at the center of decisionmaking

We need to teach our students not only how to succeed—but how to lead.

The Kingsbridge Armory must be more than a real estate project but, a legacy project.

A place where students of all backgrounds, including those with special needs, can grow academically, economically, and civically. A place that truly reflects the strength and diversity of the Bronx.

We owe our young people a future built with them not just for them.

Thank you for your time, and for the opportunity to testify on behalf of the families, students, and community members who believe in a Bronx that rises together.

Christina Callender's Testimony for Kingsbridge Armory Redevelopment

Hello Council,

My name is Christina Callender, and I am from Kingsbridge and a soon-to-be graduate of the nearby Lehman College and have been engaged with this project through NWBCC. I've dedicated my studies and professional life to understanding and alleviating the strains on working-class communities much like the one I'm from.

I'm deeply invested in projects that not only enhance economic prosperity but also improve the lives of the people who live here now. I'm in strong support for this project, however we have the opportunity to ensure that the current project is one that keeps its benefits rooted in The Bronx and a different model of development is exemplified through key efforts. To achieve that, I urge the commitment to a community benefits agreement and for the City and the Developer to commit to the following:

Firstly, there must be an accessible design. The Armory must be welcoming and usable for all residents, including those with disabilities. That means ramps, lifts, wide pathways, and clear signage designed in partnership with the disability community.

Secondly, the project must ensure truly affordable, family-sized housing that prioritizes Bronx residents in leasing. This project cannot rely on inflated AMI. so there must be some measures to counteract this to ensure that "affordability" reflects Bronx incomes, so families here can actually qualify. Units must include two- and three-bedrooms.

Thirdly, the project must emphasize local hiring and contracting. This means that jobs at every stage must go to Bronx residents, and businesses first. Contracts should be awarded to Bronx-based businesses, MWBEs, and worker cooperatives. Additionally, space needs to be made available for existing Bronx vendors to mitigate displacement and ensure that wealth circulates within our borough.

Fourthly, affordable community access to Armory uses should be prioritized. Create pricing and access policies that lower financial barriers for Bronx residents: e.g., resident discounts, sliding-scale memberships, free community hours, and no-cost space allotments for youth, seniors, and local nonprofits so the people who live here can actually benefit from what's inside.

Lastly, the city must ensure that the public infrastructure surrounding the armory matches the Armory's project's scale. The armory will draw thousands of people and the city must meet the demand. This could be done with increased bus service on the BX9 and BX22, expanded 4, B, & D train service, and safety officers to guide traffic and pedestrians during large events. The surrounding area also needs stronger sanitation services; more frequent pickup, public trash cans, and recycling bins, so the Armory remains an asset, not a burden, to the neighborhood.

This project has the potential to set a new standard for equitable development in New York City, but this will only happen if the project commits to a signed community benefits agreement and holds Bronx residents at the center.

Our youth need constructive outlets, as we see the rise of graffiti again and the endless list of senseless youth-on-youth violence. We need to bring back the spaces that Boys and Girls Clubs offered, that PAL offers, and increase weekend activities for youth that will keep them off the street but also help them shift their mindset to a growth mindset as they build community and friendship, not enemies. The armory, and its future businesses, could provide space as a Summer Youth Employment Provider (SYEP), again keeping our children in our communities and building upon the youth-based activities we propose year-round. We also need a space to provide digital literacy, at varying levels to learners of all ages. We have to move our people from solely being users of tech to being producers of tech.



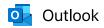



Our base is made up of Cambodian and Vietnamese immigrant and refugee communities. Mekong NYC was a signatory of the first CBA with KNIC project back in 2014 and part of the Together for Kingsbridge Working Groups participating in powerful visions for the future of the Bronx.

The Kingsbridge Armory should be a place where all Bronxites can access recreational space, community space, professional space and leisure space. Creating designating time and accessible space for Bronxites is important to the growth and investment in the local neighborhoods. The creation of a Community Council made up of broader groups of the Bronx community to watch and protect benefits to the community is needed. This will ensure that the Bronx grows and I become **decision-makers** and **owners** of the Bronx. The Community Benefit Funds dedicate 1% of project gross revenues to promote community ownership and wealth-building in the Bronx.

Please accept this written testimony as a Northwest Bronx Community and Clergy Coalition member concerning the proposed Kingsbridge Armory Project.

After decades of back-and-forth, we've finally entered what appears to be the last stretch of the armory project. The excitement in city hall is palpable, but you can still feel the tension in the community. This project **can and must work**—but only if it is planned wisely, respects community intelligence, and balances economic ambition with local integrity.

It's time to decide whether we're building a **legacy for the Bronx** or just another "big idea" that leaves its hardest-working people behind. There are still many unanswered questions about **financial sustainability** and **day-to-day operations** that no one seems ready to tackle head-on.

### I. Financial Foundation and Feasibility

The current plan leans heavily on income from:

- A 17,000-seat multipurpose venue
- Rental housing units
- Leased retail space

But here's the reality check: under existing government policies, the Kingsbridge community simply doesn't have the revenue base to sustain a project of this size.

The math doesn't work unless there's **consistent**, **high-dollar traffic from outside boroughs**, and that's a long shot.

#### A. The 17,000-Seat Gamble

The idea that 17,000 affluent suburbanites will flood the Bronx fifty times a year is, frankly, **wishful thinking**. We've already seen this movie at Yankee Stadium.

# **Regional Transit Overcrowding**

- Already stretched thin on Yankee Stadium game days.
- Metro-North adds extra stops on these days, but Bronx and Upper Manhattan riders still often pay to stand in packed trains.
- The 4 train is packed coming out of Manhattan during late afternoons and evenings—even outside weekday rush hours.
- Now imagine adding 50 more event days to that chaos.

#### **Local Transit Overcrowding**

- The 9, 22, and 28 buses serving the East and West Corridors along Kingsbridge Road and Fordham Road are **notoriously overcrowded**.
- There's barely room for walkers, strollers, or groceries, let alone surges from large event crowds.

This proposal **strains an already-strained transit system** and unfairly burdens underserved Bronx residents.

#### **Additional Concerns**

- Heavy police details before and after events
- Minimal economic benefit for local street vendors
- "Family leisure" now limited to the privileged—think pre-Hernandez, pre-Rodriguez days (chuckles)
- Most jobs are seasonal or temporary (set-up, security, cleanup), while stable, higher-paying roles go to private contractors

The community deserves better.

#### **B. Planned Affordable Housing Misaligned with Community Needs**

The proposed housing plan fails to meet the most urgent needs of Bronx residents. There is:

- No transitional housing for newly evicted families
- No group housing for foster youth and domestic violence survivors
- No housing for homeless youth
- No pathway to homeownership
- No set-aside affordable, family-size units for teachers, home health aides, or building maintenance workers commuting daily into Kingsbridge

Less commuting means more engagement—especially in our schools.

#### IV. Proposed Sustainable, Year-Round Facilities and Services

#### A. Biotechnology and Green Energy Innovation Hubs

A missing piece of the puzzle is the inclusion of:

- A biotechnology industrial hub
- A green energy innovation center

These hubs would focus on best-in-class biotechnology innovations and sustainable urban infrastructure solutions—supporting Bronx economic revitalization, attracting investment, and creating workforce pathways for **Lehman College undergraduates**.

#### B. Cultural, Educational, and Recreational Infrastructure

There's huge untapped cultural potential here—make it a creative hub, not just a commercial one.

- **Urban Gun Range** Maintain the shooting range for historical and educational purposes. Promote responsibility and safety through training—teach respect for the tool, not fear.
- Film and Theatre Complex A foreign and independent film house and stage could serve as:
  - A draw for international tourists
  - A venue for anime and children's media events
  - A home for Bronx-grown productions tied to Lehman College and Bronx High School for the Arts
  - A link to NYC's film and TV workforce pipelines
- **Library and Learning Center** Include a satellite branch for book returns and reserves, staffed by reference librarians trained in entrepreneurial, business, and family history research. Offer digital resource trainings.
- Indoor Amusement Park Offer annual passes discounted for Bronx residents (see Six Flags MD model). Encourages local use, promotes family fun.
- Horse Stables Central Park-style buggy horses could have a second life here.
- **Top Ten Golf Range** Adds recreational and revenue potential.

#### V. Spaces That Build Community

Every thriving neighborhood needs places to meet, heal, and celebrate.

#### **Free Community Spaces for:**

- Book clubs and tutoring
- Parenting and domestic violence support groups
- Freedom and anti-racism circles
- Tenant unions and civic organizing

#### Low-Cost Rental Spaces (2–6 hours) with basic amenities (sink, fridge, microwave) for:

- Memorials for unhoused or low-income residents
- Birthday and graduation parties
- Neighborhood events and commemorations

# VI. Sustainable Logistical and Governance Considerations

# A. Proposed Phased Implementation

- 1. **Prephase:** Environmental cleanup and protection
- 2. **Phase I:** Construction and core community integration
- 3. **Phase II:** Operational testing and small business partnerships
- 4. Phase III: Risk identification, quality assurance, and performance auditing
- 5. Phase IV: Continuous quality improvements and public transparency updates

### **B. Urgent Pre-Phase Maintenance and Remediation**

The Armory's current state of neglect must be addressed. The building, sitting unoccupied and unmaintained, is accelerating damage.

Starting now prevents costly problems later and signals a serious commitment to the project's future. Let's talk logistics, long-term sustainability, and transportation coordination.

#### C. Sustainable Transportation

- Develop bike and bus lanes serving Williamsbridge Metro-North, Woodlawn Station, Kingsbridge Station, Fordham Road Metro-North Station, and Fordham Road Station.
- Expand the Williamsbridge train line and the surrounding area to accommodate freight train supplies and warehousing.

# D. Oversight, Governance, and Accountability

Big projects fail when no one's watching the store. Multiple entities with distinct oversight responsibilities can make this work.

My name is Matthew Shore (pronouns: he/him), and I'm a Kingsbridge resident in the Bronx (Lenape Land) that was raised around the corner from this Armory on Creston Ave, and I'm a proud member of the Northwest Bronx Community & Clergy Coalition.

It is reassuring news that the community already secured various commitments from this project's developer...including:

- A Community fund
- Community co-governance; and,
- 125,000 square feet of community owned spaces..

With that said, I'm in support of this project. However, this project needs to go further. I urge the City and Developer to ensure:

- 1. That the Community Council have a set % of seats for seniors, local youth, persons with special needs, formerly incarcerated, undocumented persons, and formerly unhoused, to have real decision-making power.
- 2. All jobs produced after the armory is redeveloped should be at a specified living wage. Average AMI in Bronx Community Board 7 (CB7) is 38%, according to the Association for Neighborhood & Housing Development's (ANHD) 2025 Housing Risk Chart<sup>1</sup>.
- 3. Implement a community solar microgrid.<sup>2</sup>
- 4. A community fund that funds mission driven community investment trusts and/or commercial CLTs in the Bronx AND supports first-time homeownership opportunities for longtime local residents that are low-income and middle-income. According to a report published in 2022 from Pratt Institute's Graduate Center for Planning and the Environment, only 6% of homes in Bronx CB7 are owner-occupied,

which is below the Bronx (20%) and citywide average (33%)<sup>3</sup>. Additionally, according to ANHD's 2025 Housing Risk Chart, Bronx CB7 ranks highest in the city for displacement pressures, meaning its tenants face amongst the highest eviction rates, rent burden and housing code violations.

- 5. Guarantee free or truly affordable space for existing street vendors on the Kingsbridge commercial corridor in or outside the Armory, including space for them to store their equipment. Street vendors contribute to our vibrant community. Additionally, they are small businesses and should benefit from the Armory's redevelopment, instead of being displaced. Reported by THE CITY, Mayor Adams administration previously swept street vendors from the Kingsbridge Road commercial corridor, compromising their livelihoods. This is unacceptable. The City Council must support Street Vendor Project's Legislative Reform Package, too.
- 6. With the Armory's previous redevelopment projects, businesses faced double and tripled rents around the time the Kingsbridge National Ice Center was approved<sup>5</sup>. So, this current Armory redevelopment project will likely contribute to "indirect" residential and small business displacement. Currently, a dozen Kingsbridge shops face impending eviction, as reported by the Riverdale Press<sup>6</sup>. Therefore, the City should consider a special purpose district and historic district requiring local housing production to maintain a certain affordability level, preserving neighborhood character. The City should also explore commercial rent stabilization and small business bill of rights.

- 7. Additionally, the developer of this project is required, per city law, to create a Racial Equity Report (RER) through this ULURP process. Although developers are not required to present RERs to community boards and community organizations, due to the massive scale and high-profile nature of this Kingsbridge Armory project, the developer should present its RER to Bronx CB7 and thoroughly publicize the presentation to ensure many people are present to hear the presentation and ask questions.
- 8. Lastly, the developer should go further to ensure community decision-making in this redevelopment project by negotiation a legally binding Community Benefits Agreement with the Northwest Bronx Community & Clergy Coalition.

The Bronx deserves more. Thank you.

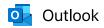

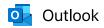

#### Good day Council,

My name is Stephina Fisher and I have been a social studies teacher in the Bronx for 18 years. My students have participated in all of the Together for Kingsbridge Working Groups.

The Kingsbridge Armory should ensure that the Bronx is a place where young become decision-makers and owners of the Bronx.

Youth Decision-Making: We hear a lot about supporting youth voices, so we need systems that create space for youth voices to have real decision-making power.

- Community Council Seats: The promised Armory Community Council and the Community Fund should have designated seats for Bronx youth.
- Voting Power: Youth should have voting power on high level decisions so that the reinvestment goes into things that youth believe have value and represent their interests.
- Youth Leadership: The City & Developer should invest in armory youth leadership programs to train Bronx youth how to join these community councils, how to effectively analyze the needs and how to represent their peers on the councils.

Youth Economic Power: When it comes to youth economic power, we hear about work based learning, internships, and SYEP.

- Beyond "internships," the armory should create apprenticeship programs that funnel into living wage and full time employment at the armory beyond.
- And beyond internships, the Community Ownership and Wealth Sharing models require a
  reframe of just "getting jobs" and toward collective decision-making and community wealth
  sharing. We need youth development in cooperative business operations, conflict resolution,
  effective communication and collective decision-making.
- Youth cooperative business hub should be developed

#### Youth Access and Affordability

- Free Vending licenses and Small Business Licenses: should be reserved for youth-run small businesses and cooperatives.
- Affordable access to light manufacturing spaces should be offered to youth for their start up cooperative businesses

In short, a Community Benefits Agreement should commit to the youth of the Bronx getting access to real decision making and real economic power in the Kingsbridge Armory.


