**Summary of Legislation:** This legislation requires the Mayor's Office of Equity and Racial Justice to provide the public with information on legal rights and resources for transgender, gender nonconforming, non-binary and intersex (TGNCNBI) individuals. Additionally, a public education campaign is required on the legal rights and resources for TGNCNBI individuals with outreach to community-based organizations providing health care, legal services, social services and housing support to the TGNCNBI community.

Effective Date: Immediately upon enactment
