Today, the Committee will be voting on a slate of legislation. Proposed Intro. Number 796-A, sponsored by Council Member Althea Stevens, is in relation to providing community boards and elected officials with notice of sidewalk shed permits, which will foster transparency for when sidewalk sheds are to be installed in communities. Number 1217-A, sponsored by Council Member Susan Zhuang, in relation to building inspections and reporting following complaints related to rats and other pests, to bolster the City's response to 3-1-1 complaints about rats and other pests, and ensure our City's building stock remains a healthy environment for all inhabitants. Proposed Intro. Number 1384-A, sponsored by Council Member Lee, in relation to requiring construction site safety trainings related to mental health and wellness, suicide risk and prevention, and alcohol and substance misuse to address the systematically high number of suicides present in the construction industry. Proposed Intro. Number 1456-A, sponsored by Council Member Justin Brannan, in relation to requiring the Department of Buildings and the Department of Small Business Services to provide education concerning the proper installation of awnings and accessory signs, and in relation to waiving penalties and fees related to such signs, to provide relief to small businesses making a good-faith effort to comply with the City's regulatory framework for accessory signs. Reso. 575-A, sponsored by Majority Leader Amanda Farías, calling on the New York State Legislature to pass and the Governor to sign legislation providing for annual adjustments to the rental and carrying charges for Mitchell-Lama developments based on increases in the Consumer Price Index. And finally, Resolution Number 1016, also sponsored by Majority Leader Farías, calling on the New York State Legislature to pass and the Governor to sign legislation setting the minimum notice period for rent increases to 60 days for

MAJORITY LEADER FARÍAS: Thank you, Chair Sanchez, for the time to speak on Resos575 and 1016.

The conditions facing Mitchell-Lama residents and the broader housing crisis in our city remain urgent. New Yorkers are being squeezed from every direction, and Trump's federal shutdown made a bad situation even worse, delaying Section 8 payments and leaving families fearing they could lose their homes. And now, with the federal rent assistance payments expected to be delayed this month, families are confronting new uncertainty at the very time they need stability the most, the holiday season. For many, this delay means entering a period already marked by skyrocketing food prices, higher utility costs, increased household expenses, and the added fear of falling behind on rent. The timing is devastating, not just financially but emotionally, for families trying to maintain even a basic sense of security. That instability ripples through our local housing systems, intensifying pressures on residents who are already stretched thin. Inside Mitchell-Lama

developments, some of the last remaining sources of stable, middle-income housing in New York, residents are navigating aging buildings, financial strain, oversight failures, and unpredictable carrying charges increases that make it harder for families to feel stable. We've seen this vulnerability laid bare at places like Jamie Towers, where years of vacancies, mismanaged funds, and delayed state intervention created deep financial distress that fell squarely on the residents. When federal support falters at the same time local systems are already strained, it creates a dangerous convergence of crises that no working family or senior should be expected to withstand, especially during a holiday

Reso. 575 addresses the financial instability at the root of many of these problems, ensuring that developments can plan sustainably without resorting to drastic last-minute increases that push residents to the edge. And Reso. 1016 ensures that residents have timely notice when changes occur, so families and seniors are not forced into crisis simply because of poor communication. New Yorkers cannot afford to wait for another round of
