**Summary of Legislation:** This legislation regulates contracts under the city's crisis management system (CMS) and requires reporting on service provider program goals, strategies, and the geographic area served. The Department of Youth and Community Development is required to notify community boards, council members, and the local precinct by letter when there is a new CMS contract or a contract termination implicating their respective geographic area.

Effective Date: 90 days after enactment
