

Revenues from All Sources Projected to Average 1.4% Growth






\$2.6 Billion More in Total Revenues for FY24-25 Since Preliminary Plan

- The Executive Plan made significant revisions to OMB's revenue projections presented in the Preliminary Plan.
- Fiscal 2024 revenues were raised by \$438 million, as projected increases in taxes and federal aid are slightly offset by a \$329 million reduction in state aid.
- Fiscal 2025 revenues have been raised by \$2.2 billion, led by a \$1.6 billion increase in City tax revenues.
- Outyear revenues were increased by \$2.3 billion on average.

\$2.2 Billion Increase in FY24-25 Tax Revenues Since the Preliminary Plan

- The Executive Plan raised tax revenues by \$619 million in Fiscal 2024, \$1.6 billion in Fiscal 2025, and an average of \$949 million in the outyears.
- **Fiscal 2024 Changes:** OMB raised its FY24 tax revenues forecast to reflects stronger-than-expected year-to-date collections through March and its outlook for the rest of the fiscal year.
- **Fiscal 2025 Changes:** The tax revenue changes for FY25 are mostly from the income-related taxes, reflecting OMB's improved forecast of corporate profits and capital gains realizations. Property tax changes are based on actuals from the tentative assessment roll, while the changes in the transactions taxes reflect projected declines in interest rates.
