**Summary of Legislation:** This legislation requires the Department of Correction (DOC) to establish and operate an online system for scheduling in-person and tele-visits with incarcerated persons. Such online system must include the ability for a person to request and reserve a date and time to visit an incarcerated person, the ability to cancel a scheduled visit, and the ability to receive notice when DOC must cancel a scheduled visit. A person who arrives after their schedule visitation time may still visit with the incarcerated person, where practicable. DOC must also provide a reason for disapproving a visitation request. By January 30, 2028, and annually thereafter, DOC must submit a report including information on the number of people who scheduled a visit using the online system and were approved, the number of people who visited an incarcerated person and the number of individuals who used the online system to request a visitation and were not approved, disaggregated by the reason for disapproval.
