2 CHAIRPERSON MAISEL: Welcome to this  
3 hearing on... of the committee on Standards and Ethics.  
4 I am the Chair with the committee, Councilman Member  
5 Alan Maisel. Today we will be holding a second  
6 hearing and vote on 14 bills. These bills were first  
7 heard by this committee in November of this year. The  
8 first of these bills is proposed introduction 1345A  
9 sponsored by the Speaker, Melissa Mark-Viverito in  
10 relation to conflicts of interest and organizations  
11 affiliated with elected officials. This bill directly  
12 addresses the concern that organizations affiliated  
13 with elected officials could raise unlimited funds  
14 even from persons doing business with the city and  
15 even when the ultimate use of these funds is for the  
16 promotion of the... that elected official. The city's  
17 campaign finance laws contribute contributions from  
18 persons doing business with the city to protect  
19 against potential influence of that money and to  
20 prevent any appearance of corruption but under  
21 current law those limitations could not be applied to  
22 the contributions received by affiliated  
23 organizations like the campaign for one New York.  
24 That is why today we are voting on the law with the  
25 same goal to protect against potential attempts to

1 influence an elected official and to prevent even the  
2 appearance of corruption through unlimited donations  
3 to an affiliated organization that promotes that  
4 elected official. We will also be voting on 13 other  
5 bills relating to campaign finance which will be  
6 discussed in more detail by their sponsors however I  
7 do want to highlight two of those bills in  
8 particular. The first is Introduction 1358 sponsored  
9 by Council Member Brad Lander in relation to an  
10 expenditure of non-public funds to assist public  
11 officers in the performance of their duties. I want  
12 to make it clear that under state laws such  
13 expenditures are already permissible and it has been  
14 argued such expenditures to support the duties of  
15 public officers should also be considered permissible  
16 under existing city law, however that is not how the  
17 campaign finance board has interpreted our laws,  
18 therefore today we will vote to clarify that  
19 situation. The second is proposed introduction 1355A  
20 sponsored by Council Member David Greenfield in  
21 relation to requiring documentation for  
22 contributions. There has been some public discussions  
23 about this bill as well as discussions between  
24 stakeholders and this bill has been amended to  
25

1 address the concerns raised in those discussions.

2 Among other requirements the bill now specifies that

3 while candidates may complete contribution cards for

4 contributors they could also do so after a

5 contribution has been made and provided that the

6 contributor then signs the completed card.

7 Alterations or changes to the contribution card after

8 it has been signed will not be permitted. This

9 amended bill that we are voting on today is a

10 reflection of the input the many stakeholders we have

11 heard from. I want to thank the sponsor of these

12 bills, Council Member Garodnick, Council Member

13 Greenfield, Council Member Lancman, Council Member

14 Lander, Council Member, Member Salamanca and Council

15 Member Van Bramer. I will now call on the Sponsors

16 present if there are any to read an opening statement

17 and I think we are just in the nick of time.

7 CHAIRPERSON MAISEL: In favor.

8 COMMITTEE CLERK MARTIN: Ferreras-  
9 Copeland?

10 COUNCIL MEMBER FERRERAS-COPELAND: Thank  
11 you Chair and I vote aye.

12 COMMITTEE CLERK MARTIN: Menchaca?

13 COUNCIL MEMBER MENCHACA: Aye.

14 COMMITTEE CLERK MARTIN: Matteo?

15 COUNCIL MEMBER MATTEO: No on 1358, aye  
16 on the rest.

17 COMMITTEE CLERK MARTIN: By a vote of  
18 four in the affirmative, zero in the negative and no  
19 abstentions all items have been adopted with the  
20 exception of introduction 1358 being adopted by a  
21 vote of three in the affirmative, one in the  
22 negative, and no abstentions, thank you.

23 CHAIRPERSON MAISEL: Alright, I'm asking  
24 that the roll be kept open for the next 15 minutes,  
25 is that reasonable and I thank everybody for their

1 participation, have a Merry Christmas, Happy Hanukah,  
2 Kwanzaa and Happy New Year.

4 CHAIRPERSON MAISEL: To reopen, to take  
5 an additional vote.

6 COMMITTEE CLERK MARTIN: Council Member  
7 Lander?

8 COUNCIL MEMBER LANDER: Thank you Mr.

10 COMMITTEE CLERK MARTIN: Final vote, all  
11 items on today's agenda for the Committee on  
12 Standards and Ethics have been adopted by a vote of  
13 five in the affirmative, zero in the negative, and no  
14 abstentions with Introduction 1358 being adopted by a  
15 final vote of four in the affirmative, one in the  
16 negative, and no abstentions, thank you.

17 CHAIRPERSON MAISEL: Alright, the... we  
18 still going to keep this open for 15 minutes, I think  
19 that we still have... that, that's it, okay. Alright,  
20 in that case thank you very much everybody.
