Summary of Legislation: This bill defines "veteran-owned business enterprise" and requires the Chief Procurement Officer to establish a mechanism by which entities have the ability to designate themselves as veteran-owned when registering to conduct business with New York City. The legislation additionally requires a Veteran Leadership Advisory Program be established within the Department of Small Business Services (SBS) to educate veteran owned business enterprises about federal, state, and city procurement opportunities. SBS must also update its reporting as needed to include recommendations for additional city procurement opportunities for veteran-owned businesses.

Effective Date: 120 days after enactment
