[GAVEL] 14 Good morning, everyone, and welcome to today's 15 hearing. My name is Diana Ayala, and I am the Deputy Speaker of the New York City Council and the Chair of 16 17 the General Welfare Committee. 18 Today, our Committee will be voting on 19 Proposed Intro. 1080-A sponsored by Council Member 20 Lee. This bill will require the Department of Social 21 Services to make information on emergency feeding programs, food benefits programs, and senior centers 22 23 available on DSS' website as well as through Access 24 HRA. The information will be provided in a way that 25 will allow users to search for an emergency feeding

1 COMMITTEE ON GENERAL WELFARE 3 program, a location to apply for food benefits 2 3 program, or a senior center by ZIP code, hours of 4 operation, and other relevant categories. The bill would also require DSS in collaboration with the 5 Department for the Aging to make written information 6 7 on emergency feeding programs, food benefit programs, and senior centers available at job centers, senior 8 9 centers, SNAP centers, and any other relevant locations. 10 Council Member Lee, would you like to 11 make a statement on your bill? 12 13 We're going to pass it over to Council 14 Member Lee. 15 COUNCIL MEMBER LEE: Thank you, Chair Ayala. Good morning, everyone. 16 17 So many of us here, whether from our work before or at the City Council, have worked firsthand 18 19 with any one of the 1.2 million food-insecure New 20 Yorkers. This 15 percent of our city is not just 21 constituents. They are our neighbors, friends, and family. As someone who used to run two senior centers 2.2 23 and Meals on Wheels programs, I've seen how our seniors can become especially desperate. Without a 24

doubt, we need more resources and food programs, but

it's also an issue of clarity and accessibility of 2 3 information. Our city is facing challenging and uncertain times, but New Yorkers should never have to 4 5 worry about or be confused about where they can obtain their next meal. With this legislation, the 6 City Council will be mandating the Department of 7 8 Social Services to make information on nearby 9 emergency feeding programs, food benefit programs, and senior centers accessible and searchable through 10 11 its website and the Access HRA application. This format will allow folks to input their ZIP code, 12 13 hours of operations, status as a senior citizen, or 14 any other relevant category. 15 Thank you so much, Chair Ayala, for your leadership and counsel in all things and thank you to 16 17 my Colleagues for all their support in this effort. 18 CHAIRPERSON AYALA: Thank you, Council 19 Member Lee. At this time, I'd like to acknowledge my 20 21 Colleagues who are already here. Council Member 2.2 Caban, Lee, Osse, Restler, Ung, and Williams. I'd also like to thank the Committee 23 Staff who worked to prepare this hearing and vote, 24

9	Council Member Lee for her leadership and think it's
10	a really great piece of legislation.
