The legislation we are voting on today will enhance transparency and improve operations at the Department of Correction and Department of Probation.

Proposed Introduction Number 420-A, sponsored by Council Member Rivera, would establish a comprehensive program for child visitors at DOC facilities.

Proposed Introduction Number 977-A, sponsored by Council Member Stevens, will increase the frequency and specificity of reporting required from The Department of Probation on programming and the number of violations issued to help the Council and the public more closely monitor the effectiveness of that agency.

Proposed Introduction Number 1023-A, sponsored by Council Member Gutiérrez, would require DOC to stablish and operate an online scheduling system to facilitate visits to people in custody.

Proposed Introduction Number 1026-A, sponsored by Council Member Hudson, would enhance jail visitation reporting requirements to illuminate the barriers that people face when trying to visit their loved ones.

Proposed Introduction Number 1036-A, legislation that I introduced would require the Department of Correction to publicly report statistical information about people in custody with a pending 730 forensic
