



Dear Land Use Committee,

Edgemere needs 100% affordable homeownership for moderate and middle class families. Responsible community development that will enrich the quality of life for current community members is what Edgemere needs. We need present day flood mitigation and infrastructure built and strengthened now, not after the City increases the density and population over another 10 to 15 years with 20,000+ more people sandwiched on this low lying sandbar community. Complete the original Edgemere Urban Renewal that we brought into.

Restoring our community with real resilient protection and neighborhood amenities doesn't have to come at the expense of overdevelopment of low and extremely low affordable apartment units housing with false promises of resiliency. These are Federal dollars that were allocated for resilience measures in our community and its 10 years since Superstorm Sandy and we are still waiting for flood, sewer upgrades and storm protection. We are a small coastal community from Beach 35th to Beach 50th St. and it should remain as such.

We lack current infrastructure; Sewer and Storm Drains Upgrades, Transportation options, Police, Hospital, Schools, Emergency Evacuation Plan, Traffic Management and Flooding. Community Members along the bayside of Edgemere don't even know about the CLT, no community outreach was done by HPD. Just a few weeks ago, a Gas Main was struck on Mott Ave, no emergency plan was in place, people walking and carrying on the daily business with no knowledge of the presence of imminent danger.

As a resident of Beach 46 St and a member of the Garden by the bay, I'm writing to offer my testimony about the proposed zoning changes for the Edgemere neighborhood. While many aspects of the plan are attractive (new parks, etc) I feel that the zoning changes that have been proposed are likely to dramatically impact quality of life in this neighborhood—traffic, a sense of civic disorder wrought by a rapid influx of newcomers—and they have not been properly communicated to the community. Moreover, the coastal hazard zone downvoting will have an immediate impact on the property value of homes in that area, essentially taking capital out of the pockets of working families. This type of neighborhood makeover should be done with much more active input from the community, which for a community like ours requires much more direct outreach and explanation than this proposal has involved.
