My name is Joseph Sayegh and I live at [REDACTED] Brooklyn, NY.

I am quite concerned about the zoning change being considered for construction at 1880-1888 Coney Island Avenue.

The first concern is the unprecedented height and size of the property which will negatively impact all renters and homeowners on east 10th street. Majority of homes here are 1-3 family homes and the area is already heavily congested. Adding 230 apartments plus commercial will wreak havoc on an already overpopulated and overburdened neighborhood. The additional car traffic and pedestrian traffic will add to the dangerousness of Coney Island Ave. Additionally, the apartments do not accommodate the needs of the neighborhood demographic, who are mostly families and need a minimum of 3 bedrooms. Hello City Council,

Thank you again for taking the time yesterday to hear from those of us in the community about the zoning request for 1880-1888 Coney Island Avenue,

My name is Steven Greenberger and I live at [REDACTED] 11230.

I am one of the people OPPOSING this zoning change.

Yesterday we were limited to two minutes a piece, so I only managed to get one point in, however here are more of my concerns, which I hope you will take into consideration when you vote against this project.

Traffic - Putting up this building with retail space and hundreds of apartments will bring hundreds of new cars to the area. Currently, the area is deadlocked, with traffic on Avenue O hitting a One Way on Coney Island Avenue, and similarly on Quentin Road, both within one block of this proposal. Most of the time it can take upwards of 5-10 minutes just to go a few blocks, as the intersections are congested and traffic just has nowhere to go.

On top of this, the corner of Coney Island Avenue and Avenue O is a very dangerous corner. There have been numerous accidents over the years, resulting in studies by the Department of Transportation, leading to the installation of pedestrian facilities and islands in the median to help passengers get out of harm's way.

Parking - Parking in the neighborhood is currently at maximum capacity. The houses and apartment complexes already in the area all need room to park, and the local autobody shops have no issues taking up any remaining spaces.

While the building is proposing hundreds of parking spots internally, unless these are free to all residents and retail shoppers and employees, the general public is going to be more inclined to look for street parking, exacerbating the aforementioned traffic issues, as well as straining the current parking situation.

Danger - There is a large concern about the safety of the neighborhood with this new zoning proposal. The neighborhood is full of families with young children, and some of the proposal is concerning.

Adding a "Pocket Park" in the backyards of the neighboring structures is an invitation to smoking and other late-night activities which are not child friendly.

The site currently includes a parking lot that has seen sports cars doing burnouts (and ending up driving through people's backyards on accident) and smoking/partying at all hours of the night. These lots have been owned by one owner for many years, the same one who is coming to you now with this proposal to change the zoning. I do not think that there would be a culture change with a change of scenery.

Sunlight - The houses on East 10th Street, directly behind this proposal, all benefit from the morning sun. We use it for newly installed Solar Panels (something which Con Edison encourages), and to be able to enjoy the natural light, which leads to healthy living. Putting up this large of a structure will hinder the morning sunlight, and while the developers may show other buildings in the area of similar heights, they are all East of Coney Island Avenue, and not in the current neighborhood being discussed.

Change of Zoning - If we make an exception for this lot, it opens it up to the rest of the block to change their zoning as well. Before we know it, a quiet residential neighborhood has turned into a bustling commercial/residential hub.

Now, please don't mistake this as a full-out war against the landlord and changing the culture of our neighborhood. In fact, we are a very diverse neighborhood, with many institutions within a block of this proposed site.

These include but are not limited to:

Dynamite Youth Center, a facility to help troubled youth get back on their feet

A brand new community center with a Hallal Food Pantry

St Brendan's Catholic Church

Congregation Yam-Hatorah Synagogue

Council Center for Senior Citizens

Jewish Board of Family and Children's Services

We welcome change and development to our neighborhood, but in ways that will help give back to the community, and not be a hindrance to those that have made this area their home for many decades.

I am strongly opposed to the proposed development of this site into a mixed use edifice with 8 story building and units for over 200 residents at 1880 to 1888 Coney Island Avenue in Brooklyn between Avenue O and Avenue P.

There is a deficit of affordable housing in the surrounding community as it is. Most residents live and work in the vicinity and do not depend on public transport. A large family size necessitates use of a car or minivan. The proposal is for studio, one and two bedroom apartments giving the developer the most "bang for his buck". There is no guarantee that the "affordable units" will help the current residents who are spending 50% of their income on rent or serve their housing needs. The surrounding blocks suffer in the hotter weather from serious reduction of voltage putting the elderly and infirm who depends on lifesaving equipment at risk, the infrastructure cannot support 230 more users on the local grid. More people= more garbage and litter. We already have an issue with sewers grates and catchbasins overflowing when there is steady heavy rain . However, the application continues to go on to higher levels like the Borough President who found it "conditionally favoring" if the developers modified the plan to address some of the concerns (a motion which is not policed by any body to assure compliance!). Next up the ladder is the City Planning Commission and if you watched the video only 1 person was bold enough to revisit the concerns of this project and note that the information he requested in prior meetings has still not been provided. Nonetheless, the rest of the committee pushed forward to get to a voting session and voted to "approve" the application. You see where this is going... there is a mandate to build and a directive to remove all obstacles from

attaining that goal. The City Council will soon review and vote on the application and then its off to the Mayor for his review and vote.

So what's wrong with more housing? Isn't it a good thing after all? Well... it depends where you put it.
