2 SERGEANT-AT-ARMS: Check one, two. Check 3 one, two. This is a prerecorded sound test for the Committee on Finance. Today's date is March 2, 2023. 4 It's being recorded by Michael Leonardo in the 5 Committee Room. 6 7 SERGEANT-AT-ARMS: Good morning and welcome to today's New York City Council hearing on 8 9 the Committee on Finance. Folks, quiet please, quiet 10 please. 11 Good morning and welcome to today's New York City Council hearing for the Committee on 12 13 Finance. 14 At this time, we ask that you silence 15 cell phones and electronic devices to minimize 16 disruptions throughout the hearing. We thank you for 17 your cooperation. 18 Chair, we are ready to begin. 19 CHAIRPERSON BRANNAN: Thank you. [GAVEL] 20 Good morning and welcome to today's Finance Committee 21 meeting. I'm Council Member Justin Brannan. I have the privilege of Chairing the Committee on Finance. 2.2 23 I've been joined by Council Members Kagan, Hudson, Farias, Carr, Powers, Hanks, Barron, Osse, and Louis, 24 25 and Moya and Sanchez are on Zoom.

2	Today, our Committee will be voting on						
3	the following items, the Council's FY-24 operating						
4	budget, a revenue budget modification, a transparency						
5	resolution, an Article 11 resolution, and finally						
6	Intro 524-A.						
7	First, we've got the Council's FY-24						
8	operating budget and the accompanying OTPS schedule.						
9	The Council's Fiscal '23 proposed budget includes						
10	75.7 million dollars for personal services and 24.3						
11	million for OTPS, which stands for other-than-						
12	personal services.						
13	Next, the revenue budget modification						
14	recognizes 1.69 billion of new revenue in FY-23 and						
15	authorizes the appropriation of that new revenue to						
16	increase the Budget Stabilization Account by 1.46						
17	billion to prepay FY-24 debt service in FY-23 and						
18	increase the general reserve by 225 million to						
19	maintain funding.						
20	Next, we've got the transparency						
21	resolution which sets for the new designation and						
22	changes in the designation of certain organizations						
23	receiving certain local aging and youth discretionary						
24	funding and funding pursuant to certain initiatives						
25	in the budget. As with all transparency resolutions,						

2	Council Members will have to sign a disclosure from						
3	indicating whether or not a conflict exists with any						
4	of the groups on the attached list. If any Council						
5	Member has a potential conflict of interest with any						
6	of the organizations listed, they have the						
7	opportunity to disclose the conflict at the time of						
8	their vote. As a reminder, please disclose any						
9	conflicts you may have with proposed subcontractors						
10	used by organizations sponsored by discretionary						
11	funding. These disclosures must be made before the						
12	subcontractor can be approved for funding. Disclosure						
13	forms must be completed and submitted prior to the						
14	vote on the transparency resolution and may be						
15	emailed to Julius Caranda who is also present today						
16	in Chambers to take your questions.						
17	Next, an Article 11 resolution will						
18	authorize a full 40-year Article 11 exemption to						
19	support the preservation of one 241-unit co-op						
20	building in Council Member Richardson Jordan's						
21	District. The amendment will allow for renovation						
22	work and refinancing the building debt to allow						
23	maintenance to remain affordable for current and						
24	future shareholders.

2	Finally, Intro 524-A sponsored by my					
3	friend, Council Member David Carr, would authorize a					
4	new interest rate for primary resident homeowners who					
5	enter into payment plans with the City and stay					
6	current on those plans. The new rate would be set by					
7	Council Resolution at a later date following					
8	recommendations from the Banking Commission and would					
9	be open to property owners with a combined income of					
10	no more than 200,000 dollars and whose property has					
11	an assessed value no more than 250,000 dollars.					
12	Property owners who are not paying their outstanding					
13	taxes would still be charged the standard late					
14	interest rate.					
15	I want to recognize Council Member Carr					
16	if he has any remarks on his bill. Council Member.					
17	COUNCIL MEMBER CARR: Thank you, Chair					
18	Brannan. Good morning, Colleagues. Intro 524-A is					
19	going to resolve a longstanding policy dilemma that					
20	we as a Council face every budget year and have faced					
21	for I think longer than most of us can remember,					
22	which is how do we set an interest rate that punishes					
23	and deters tax scofflaws, people who just don't want					
24	to pay their tax bills, while at the same time not					
25	punishing homeowners who are simply struggling to					

2	make ends meet, maybe they had a bad year, they lost						
3	an income earner or someone lost their job, they're						
4	seniors on a fixed income, maybe as my grandmother						
5	would say they're house rich but cash poor. We want						
6	to make sure that folks who are trying to make an						
7	earnest effort to dig themselves out of a tax arrear						
8	hole can do so without the City making it more						
9	difficult by giving them a higher interest rate so						
10	this bill is going to allow us to do that later in						
11	June when we do the interest rate adoptions. We're						
12	covering 80 percent of homeowners potentially based						
13	on the income threshold and so I think this is a						
14	really, really good piece of legislation that is						
15	going to help a lot of New Yorkers across the five						
16	boroughs. Chair Brannan, I thank you for all of your						
17	support and leadership on this issue. I thank the						
18	Staff, I'm going to be thanking them individually on						
19	the floor later today, they did yeoman's work in						
20	making sure this got done, and I'm just so pleased						
21	that we're voting to report it out this morning.						
22	Thank you so much.						
23	CHAIRPERSON BRANNAN: Thank you, Council						
24	Member. Are there any other comments or questions						

2 from my Colleagues on any of the items today? Council 3 Member Louis.

4 COUNCIL MEMBER LOUIS: Sorry. I really wasn't trying to make this long for you, Chair. I was 5 just looking through this packet and noticed that 6 7 Welcome NYC does not have a Haitian organization to provide services. I think we've heard from thousands 8 9 of Haitians that have migrated here from the border that they need assistance with case management. I've 10 11 met with organizations like Hope that's located in Queens in Council Member Williams' District that's 12 13 asked over and over again for additional support 14 services so that they can provide support across New 15 York City, and I got a call from Finance that they 16 would add a group and they did not so I just want to 17 highlight that for the record that while there are 18 some amazing groups on here, we have some Haitian 19 folks that do need additional case management 20 services as opposed to just legal services, and I'm 21 hoping that a change can be made in the next 2.2 transparency resolution. Thank you so much, Chair. 23 CHAIRPERSON BRANNAN: Work on that. Anyone else? Council Member Barron. 24

3	200,000 of that is going in the reserve budget?					
4	CHAIRPERSON BRANNAN: I think the total					
5	amount was 225.					
6	COUNCIL MEMBER BARRON: Is going in					
7	reserve. I just want to go on record saying I oppose					
8	that. I think it should be used to offset the cuts to					
9	all the agencies that the Mayor is engaging in as					
10	opposed to putting it in the reserve account that					
11	already has 8.3 billion. While I support prepaying					
12	the debt service because that will help us next year,					
13	but it should not be put into the reserve account.					
14	CHAIRPERSON BRANNAN: Okay. Anyone else?					
15	We've also been joined by Council Member Brewer.
