Chair Salamanca will now continue with today's agenda.

CHAIRPERSON SALAMANCA: Thank you, Counsel.

Today, we will vote to approve LUs 237 and 238 for the 1656 West 10th Street Rezoning proposal in Council Member Yeger's District in Brooklyn. This proposal would change an existing R5 zoning district to an R6A zoning district and establish an MIH program area utilizing Option 1 and 2 to facilitate the construction of a new six-story mixed-use building.

We will also vote to disapprove LU 231 related to 43rd Avenue Demapping proposal in Council Member Paladino's District in Queens. The applicant sought to legalize a retaining wall that encroaches

onto 43rd Avenue. For the reasons stated by Chair
Riley and Chair Paladino at the Zoning Subcommittee
meeting earlier today, the Council should disapprove
the application.

Finally, I note that the application for LU 230 relating to the 189-10 Northern Boulevard Commercial Overlay also in Council Member Paladino's District in Queens has been withdrawn. Therefore, pursuant to Council Rule 11.60b, LU 230 is void, and I make a motion to file the item to remove it from the Council's calendar.

At this time, I would like to welcome my Colleagues who might wish to ask questions or make remarks.

Seeing none, I now call for a vote with the support of the local Council Members to approve LUs 237 and 238 and to disapprove LU 231 and to adopt a motion to file LU 230. Would the Clerk please call the roll?
