| 19 | Introduction 1048-A. This bill seeks to address major |
| 20 | bureaucratic hurdles faced by our non-profit partners |
| 21 | and human service providers across New York City, the |
| 22 | burden of repeatedly submitting the same duplicative |
| 23 | paperwork to multiple City agencies when bidding on |
| 24 | City contracts. Whether it's certificates, |
| 25 | organizational documents, financial statements, or |

other materials, nonprofit organizations currently 2 3 spend inordinate amounts of time sending City 4 agencies nearly identical information through 5 separate procurement processes. This represents wasted effort and does nothing to help connect 6 7 vulnerable New Yorkers with vital services. By 8 establishing a centralized and secure electronic 9 document vault, proposed Intro. 1048-A provides a 21st century solution allowing providers to simply 10 11 refer agencies to required documents already submitted and stored digitally in one consolidated 12 13 document repository.

14 Streamlining and consolidating documents 15 in this commonsense way will alleviate headaches for 16 both vendors and contracting agencies. It will also 17 free up precious time and resources for non-profits 18 to focus on service delivery rather than endless 19 administrative work. As a Council, we have heard far 20 too many stories of non-profits working after hours 21 of working weekends just to meet City paperwork 2.2 demands. Many nonprofit organizations find themselves 23 so bogged down in paperwork that they cannot bid on funding opportunities or even spend awarded funds 24 this time. This legislation delivers sorely needed 25

2 guardrails and infrastructure upgrades to bring 3 efficiency to outdated, duplicative bureaucratic 4 processes.

If nothing else, this bill epitomizes 5 good, responsible government. I am proud of 6 7 sponsoring this legislation, and I urge your support 8 today for this solution that empowers City 9 contractors through smarter use of technology and greater interagency coordination. Thank you for your 10 11 partnership and commitment to reforming procurement practices that too often lose sight of real people 12 and real outcomes. 13
