3	CHAIRPERSON KOSLOWITZ: Good morning and
4	welcome to the Committee on Rules, Privileges and
5	Elections. My name is Karen Koslowitz, and I am the
6	Chair of the Committee on Rules, Privileges and
7	Elections. Before we begin, I would like to
8	introduce the member of this Rules Committee present.
9	First, we are honored to be joined by-Well, no we're
10	not. He's not here yet. [laughter] I want to
11	introduce Minority Leader Steve Matteo, Council
12	Member Adrienne Adams, Council Member Margaret Chin,
13	Council Member Mark Treyger, Council Member Margaret-
14	I said Margaret Chin already, and as we go along,
15	we'll be joined by other members of the committee.
16	And before we begin, I want to introduce the staff of
17	the Council to the Committee and the staff. I would
18	like to acknowledge Elizabeth Guzman, who's the
19	Counsel to this committee. I would also like to
20	acknowledge the staff members from the Council's
21	Investigative Units: Chuck Davis, Chie of Compliance
22	Officer, and Andre Johnson Brown. First, we will
23	consider and vote on the nomination by the Mayor of
24	Mr. Steven Kest for appointment to the New York City
25	Taxi and Limousine Commission. We will then consider

I know you very well Oudeshram Raj Rampershad 4 5 for appointment as a member of the New York City Planning Commission. In New York City Taxi and 6 7 Limousine Commission known as the TLC was created pursuant to Local Law 12 of 1971. Chapter 65 of the 8 New York City Charter establishes the TLC with the 9 10 goal of developing and improving Taxi and Limousine service in New York City. TLC is responsible for 11 12 overall transportation policy. The Commission 13 establishes certain rates, standards and criteria for the licensing of vehicles, drivers, chauffeurs, 14 owners and operators. The Commission includes nine 15 16 members appointed by the Mayor with the advice and 17 consent of the Council. TLC must include at least 18 one member from each borough. TLC members are appointed for a terms of seven years, and can serve 19 until the appointment and qualifications of a 20 successor. [coughs] The Mayor designates one TLC 21 2.2 member to act as the Chair and Chief Executive 23 Officer. The Chair has the power to employ, assign and oversee the officers and employees of the 24 organization. Pursuant to the Charter, the Chair's 25

2	position is full time and the Mayor sets
3	compensation. The Chair currently receives \$212,044
4	annually. No other TLC member receives compensation.
5	Should all TLC and all documents and records in its
6	possession are public records. TLC must also submit
7	and annual report to the Council on or before the
8	second Monday of January. Should candidate Kest be
9	appointed to the TLC, he will fill a vacancy and
10	serve for the remainder of the seven-year term that
11	expires on January 31, 2019. Can we swear in Mr.
12	Kest, please?
13	LEGAL COUNSEL GUZMAN: Welcome, Mr. Kest.
14	Would you please raise you right hand to be sworn in?
15	Do you sear or affirm to tell the whole truth and
16	nothing but the truth during this testimony?
17	STEVEN KEST: [off mic] I do.
18	LEGAL COUNSEL GUZMAN: Thank you. Do you
19	have a statement you would wish to make?
20	STEVEN KEST: [off mic] Yes, I do. Good
21	morning. [pause]
22	MALE SPEAKER: There you go.
23	STEVEN KEST: Alright, thank you and
24	members of the Committee on Rules, Privileges and
25	Elections. My name is Steven Kest, and I'm grateful

1 COMMITTEE ON RULES, PRIVILEGES AND ELECTIONS 6 2 to Mayor de Blasio for nominating me to serve as a member of the Taxi and Limousine Commission. 3 The 4 primary reason that I want to serve on the TLC is because I want to be an advocate for the drivers 5 whether they drive yellow cabs, green cabs of for-6 7 hire vehicles, the drivers work hard. They don't get paid enough. Their expenses are too high, and they 8 deserve a TLC that's looking out for their interests. 9 10 I know the TLC has to balance the sometime competing interests of all resident of the city not just driver 11 12 but also riders and the general public. I**′**m confident that I'll be sensitive for the variety of 13 14 constituencies, that the TLC is responsible to, but I 15 firmly believe that in the long run the entire city 16 is better served if we have well compensated, stable and profession core of drivers. My entire career has 17 18 prepared me for this appointment. For over 35 years I worked as a community organizer with ACORN, the 19 20 foremost organization of poor and working people in the county. At ACORN I helped organize people so 21 2.2 they had power to win a better life. ACORN is the 23 leading national organization in fighting for living wages for workers. We also led the fight against 24 25 abusive and predatory lenders. Both of these

COMMITTEE ON RULES, PRIVILEGES AND ELECTIONS 1 7 2 campaign areas relevant to my perspective position at the TLC. After ACORN, I joined the staff of the 3 4 Service Employees International Union, and for five years, I helped lead the Fight for 15, a national 5 campaign of fast food cooks and cashiers who helped 6 7 win wages of \$15 an hour for millions of workers all across the country. I'm currently work as a senior 8 advisor at the Center for Popular Democracy where I 9 helped train and support community organizations in 10 35 states. Here in New York City CPDs, affiliates 11 12 and partners include the Working Families Party, Make 13 the Road New York, New York Communities for Change, 14 Vocal and Churches United for Fair Housing, all 15 organizations that are working to advance the 16 interests of low and moderate income New Yorker. My 17 firm belief is that Taxi, FHV drivers and commuter 18 vans like all workers-drivers-like all workers are best served by organizing. My pledge to you as a 19 prospective TLC member is that I'll listen closely to 20 the voices of the drivers as it is expressed through 21 2.2 their organizations like the Taxi Workers Alliance 23 and the Independent Driver Guild along with any other organizations the drivers organize and support. 24 In 25 particular I plan to study the proposals that have

2	been put forth by the TLC and by members of this
3	Council that are designed to raise wages for the
4	drivers. At first glance these proposals represent
5	significant advances, and as I learn more about them
6	and about the concerns of the drivers, I hope I'll be
7	a constructive advocate as these policies are
8	finalized. In conclusion, let me say that I'm
9	honored that the Mayor has nominated me to serve on
10	the Commission, and I look forward to working closely
11	with members of the Council in that capacity. I'd be
12	happy to answer any of your questions.
13	CHAIRPERSON KOSLOWITZ: what safeguards
14	would you recommend to ensure that dishonest taxi
15	drivers do not overcharge riders?
16	STEVEN KEST: That's one of the areas
17	that I've heard about, and I hope to look into it and
18	learn more about it once I get on the Commission, but
19	that seems an important issue to address.
20	Absolutely.
21	CHAIRPERSON KOSLOWITZ: Because I know.
22	I take-I take cabs. I do not drive
23	STEVEN KEST: [interposing] Yes.
24	CHAIRPERSON KOSLOWITZ:and many times
25	I've gotten into a cab where they don't even put down

2	the meter. They, you know, tell me-they'll say to me
3	how much-how much does the ride usually cost? And,
4	you know, I will tell them, and I happen to be honest
5	and I tell them exactly because I take cabs a lot,
6	but that money gets put into their pockets. They
7	don't have to report that money because there's no
8	record of
9	STEVEN KEST: [interposing] Uh-hm.
10	CHAIRPERSON KOSLOWITZ:having a
11	passenger. How—how can you address this on a whole
12	with, you know, with the rest of the Commissioners?
13	STEVEN KEST: Yeah. No, that seems like
14	an important issue address [coughing] and I—I know
15	that there's and Enforcement Division at the TLC and
16	I will definitely be focused on issues like that.
17	CHAIRPERSON KOSLOWITZ: Okay. Also the
18	taxi industry is, you know, facing some really tough
19	financial times at this point, and they're missing
20	payments on their loans, and some have even ended
21	their lives because of their financial troubles.
22	What can the TLC or the city do to alleviate some of
23	the financial burdens medalion owners face?
24	STEVEN KEST: Yeah, I know this-it's been
25	a tragic, tragic situation. I mean, look, I-I've

2	spent all of my life as a organizer working to
3	advance the interests of poor people and working
4	families, and I think that's why I want to serve on
5	the Commission so I can really sort of dig into those
6	issues, and help craft policies that will address
7	exactly the problems that you're raising. So, that's
8	why I want to take on this responsibility.
9	CHAIRPERSON KOSLOWITZ: I know that
10	that's fair to make sure that the, you know, the
11	people have-feel that they can come and speak to, you
12	know, the commissioners at, you know, the times of-of
13	need and maybe get some advice from them
14	STEVEN KEST: Yes.
15	CHAIRPERSON KOSLOWITZ:and not feel so
16	alone.
17	STEVEN KEST: No, I think absolutely that
18	seems right. Yep.
19	CHAIRPERSON KOSLOWITZ: Okay, any of my
20	colleagues have any-what? [background comments,
21	pause] Council Member Chin.
22	COUNCIL MEMBER CHIN: Thank you, Madam
23	Chair. Mr. Check-Kest
24	STEVEN KEST: [interposing] Yes.
25	COUNCIL MEMBER CHIN:welcome.

3	COUNCIL MEMBER CHIN: Looking at your
4	background and from your testimony I'm really excited
5	that you joined the TLC that we have another activist
6	voice on there, and from my own personal experience
7	in terms with interacting with the-the Chairperson
8	and TLC on the commuter van issue, and I agree with
9	you that organizing is really crucial. We were able
10	to organize the community van-commuter van operators
11	who were operating legally, but-and TLC was pushing
12	for this decal to show that these are the official
13	legal vans that have insurance, and provide the
14	safety, and because they were able to come into TLC
15	and sit down with TLC staff and the-the Chair, that
16	they were able to work together. And they were also
17	very excited to let the customer know that these are
18	the safe ones
19	STEVEN KEST: [interposing] Yeah.
20	COUNCIL MEMBER CHIN:and these are the
21	ones that you should be riding, and they were able to
22	work with us to get an official commuter stop. So, I
23	really look forward to seeing more of that
24	interaction. You know as the Commissioner hopefully
25	you will be proactive and work with Council Member if
I

2	we have situations that we wanted to reach out to
3	you, but also I think looking at the-the issues with
4	the drivers especially taxi drivers I myself also
5	take cabs whenever I need. But what happened, you
6	know, with the app with Uber and-and all the app,
7	what I've seen is a lot more issues with congestions,
8	and granted, it's very convenient for the customers,
9	but it really hurts I think the taxi industry because
10	you have to Most of the time you could get a cab
11	in Lower Manhattan easily just get on any corner and
12	you can get one, but unfortunately, there are people
13	who want the service right in front of their doors or
14	drop them off right in front of their office, and
15	that really causes a lot of issue. But I think that-
16	I hope that you will, you know, work with
17	organizations, you know, like Taxi Workers Alliance
18	and with us in the Council to find a way to help
19	these drivers make a decent living, and to be able to
20	continue to work in our city.
21	STEVEN KEST: Great. Thank you. I
22	promise I will, and I live in Brooklyn not far from
23	Flatbush Avenue. So, I'm-I've ridden the dollar
24	vans, the commuter vans, and I'm familiar with those
25

COUNCIL MEMBER CHIN: So, with the dollar 4 van we have to find a way to help them legalize. 5 I mean like even in Chinatown we have the legal one, 6 7 and the illegal ones. So, we got to really help them. 8 9 STEVEN KEST: Yep. 10 COUNCIL MEMBER CHIN: If you want to make a living, follow the rules and we will help you. 11 12 STEVEN KEST: Yep. 13 COUNCIL MEMBER CHIN: Thank you. Thank 14 you Chair. 15 STEVEN KEST: Yep. Thanks. 16 CHAIRPERSON KOSLOWITZ: Okay. Council 17 Member Treyger. 18 COUNCIL MEMBER TREYGER: Thank you. Thank you, Chair Koslowitz and congratulations Mr. 19 20 Kest on your nomination. 21 STEVEN KEST: Thank you. 2.2 COUNCIL MEMBER TREYGER: I-I really 23 appreciate your attention and focus on making, you 24 know, on the livelihood of the drivers and making sure that we're sympathetic and empathetic to their 25

Recently the City Council voted on a contentious piece of 3 legislation with regards to-whether you call it 4 5 capping or pausing for your-for-hire vehicle licenses to deal with this issue of congestion and come up 6 7 with regulations and ideas on how to better deal with it, but one of the things that-that has-that came out 8 of the legislation was really this creation of a new 9 office or a new area of focus with regards to dealing 10 with the fact that historically, and-and we still 11 12 hear cases today where particularly people of color are being denied service. In-in this day and age 13 14 it's just unacceptable, and so I-it is our hope and 15 expectation that this new office that was created as 16 a result of this legislation is given all the support 17 and the attention that it deserves to make sure that 18 this just does not happen any more. So, that's first and foremost. The other issue that I just want to 19 bring to your attention, and you're from Brooklyn, I-20 I heard, so am I. There are times when we have been 21 2.2 denied service if we're in Manhattan asking for a 23 trip to Brooklyn and we're told no and get out of the 24 car.

3	this just-this should not be happening, and so as we
4	first and foremost, you know, are sympathetic and
5	empathetic to the challenges, significant challenges,
6	which they face, they would be better served with the
7	public if they truly can every single day practice
8	that type of equity and fairness and-and basic
9	decency to everyone in New York City, and I think
10	it's worth emphasizing particularly when we're
11	considering a nomination to a new Commissioner on-on
12	TLC. This legislation will be reviewed within a
13	year, and we'll probably circle back with TLC about
14	what new ideas and proposals will happen, but there
15	are some of the issues that came up during this
16	contentious legislation. I would like to hear your
17	thoughts on them and again, I congratulate you on
18	your nomination.
19	STEVEN KEST: Great. Yeah, thank you.
20	Yeah, I totally agree. I mean there is no place for
21	that type of discrimination in any sector and, you
22	know, I spent all of my career fighting those types
23	of abuse whether it was by—by bankers denying loans
24	to people of color or landlords denying leases, et
25	cetera. So, I'm absolutely sensitive to those

1 COMMITTEE ON RULES, PRIVILEGES AND ELECTIONS 16 2 issues, and-and that is one of the things that I certainly agree with you and need to address. 3 4 [pause] CHAIRPERSON KOSLOWITZ: Council Member 5 6 Treyger are you finished. 7 COUNCIL MEMBER TREYGER: [off mic] Yes, Chair. 8 CHAIRPERSON KOSLOWITZ: Okay. Council 9 10 Member Lancman. 11 COUNCIL MEMBER LANCMAN: Good morning. 12 STEVEN KEST: Good morning. 13 COUNCIL MEMBER LANCMAN: I was very excited to hear about your nomination. It's-you're 14 15 going to have lots of issues to deal with as a member 16 of the-the TLC, and the issues that are raised by my 17 colleagues are all very important, and-and I know 18 you're going to do the right thing. I do hope that you-you take as your mandate on the TLC that the 19 20 mission to make the lives of drivers better. I hope that you will work with the Taxi Workers Alliance 21 2.2 and-and with others, and make that a focus of your 23 tenure. I and all my colleagues do represent many fore-hire vehicle workers. Almost all of them who 24 are-of whom are-are immigrants, and it's so important 25

3	meetings and those hearings and those conversations
4	with that mission and that sensitivity, and I hope
5	you will be that person, and I hope you'll do all the

8	why you're there. Yeah, I'd vote for that. (sic)
9	STEVEN KEST: I appreciate that, Council
10	Member and that is-that will be my mission. So,
11	thanks.
12	CHAIRPERSON KOSLOWITZ: Council Member
13	Adams.
14	COUNCIL MEMBER ADAMS: Yes, I will also
15	echo the sentiments of my colleagues as well and
16	congratulations on your appointment. As one who
17	represents Southeast Queens and the numerous for-hire
18	vehicles, and drivers, Yellow cabs in particular,
19	there is a heart felt need for someone of your
20	caliber and character to join the TLC. So, as my
21	colleagues have said, we really, really do hope that
22	you are that breath of fresh air of sensitivity that
23	is needed on the TLC. We congratulate you for the
24	appointment, and we really, really hope that you will
25	be the voice for the voiceless out there. Thank you.

12	comments] Alright. We're just going to have Council
13	Member Matteo vote.
14	CLERK: [interposing] Appointment for Mr.
15	Kest, continuation roll call, Council Member Matteo.
16	COUNCIL MEMBER MATTEO: No.
17	CLERK: The vote now stands at 6 in the
18	affirmative, and 1 in the negative.
19	CHAIRPERSON KOSLOWITZ: I know Mr.
20	Rampershad for many years. I've worked very closely
21	with him when he was the Chair of Community Board 9,
22	and he has done our community justice, and I know
23	that he will do the same on City Planning. I have
24	Board 9 in my district. I have a nice piece of it,
25	and I believe Council Member Adams also has Board 9

in the district. So, I look forward to working with
you in another capacity.

## RAJ RAMPERSHAD: Thank you.

5 CHAIRPERSON KOSLOWITZ: And now pursuant 6 to the New York City Charter the Planning Commission 7 must consist of 13 members. The Mayor appoints seven members including the appointment of Commissioner 8 Chair, the Public Advocate appoints one, and each of 9 10 the five borough presidents appoints one. [door bangs] with the exception of the Commission Chair. 11 12 Appointments to the Planning Commission are subject 13 to the advice and consent of the Council. Planning Commission members serve for staggered five-year 14 15 terms and may serve an unlimited number of terms. 16 The Chair receives an annual salary of \$214,413. The 17 Vice Chair a salary of \$65,121 and members a salary 18 of \$54,150. Planning Commission members have several responsibilities including city planning for future 19 20 developments, assisting the Mayor in developing capital programs, overseeing environmental reviews, 21 2.2 preparing zoning and planning reports. Should 23 candidate Rampershad be appointed to the Planning Commission, he will fill a vacancy and serve the 24 25 remainder of a five-year term expiring June 30, 2023.

Should I swear him 6 7 first or--? 8 CHAIRPERSON KOSLOWITZ: You will resign 9 Community Board 9? 10 RAJ RAMPERSHAD: Yes, I will. CHAIRPERSON KOSLOWITZ: Okay, raise your 11 12 right hand and let's swear you in. 13 LEGAL COUNSEL GUZMAN: Do you swear or 14 affirm to tell the truth, the whole truth during the 15 testimony you're about to give. 16 RAJ RAMPERSHAD: I do. 17 LEGAL COUNSEL GUZMAN: Thank you, and can 18 you restate you're stepping down from the Community Board 9? 19 20 RAJ RAMPERSHAD: Yes, I will resign from the Community Board right after the vote is taken. I 21 2.2 already prepared the email [laughs] so--23 LEGAL COUNSEL GUZMAN: Right, thank you. 24 Do you have a statement you wish to make? 25 RAJ RAMPERSHAD: Yes, I do

4 RAJ RAMPERSHAD: Good morning Chairperson Koslowitz and members of the Committee on Rules, 5 6 Privileges and Elections. My name is Oudeshram 7 Rampershad, but everyone calls me Raj. I would first like to thank Queensborough President Melinda Katz 8 for nominating me for this position, and thank you 9 all for allowing me to testify before you today. I 10 would also like to take a moment and acknowledge the 11 12 late Irwin Cantor who served for 23 years in the position for which I have been nominated. If I'm 13 confirmed, I will do everything in my power to 14 15 maintain the respect, the integrity and the tenacity 16 that Mr. Cantor brought to the position. I've been a 17 life long resident of Richmond Hill, Queens, and it 18 would be a distinct privilege to represent my borough on the City Planning Commission. My parents migrated 19 here from Guyana. My father came in 1969 and my mom 20 came in 1971. They had two children, my brother and 21 2.2 Like so many people before them, they came here me. 23 to live the American Dream. My dad worked for Liberty Line Buses. He went to RCA Technical School 24 and served in the United States Air Force stationed 25

My mom also worked several jobs for a time at a department store and 3 4 then at Key Food Supermarkets where she went from 5 being a cashier to a supervisor. Eventually, with 6 her partner she opened up a meat and grocery business 7 in Losen Park, Queens. It was our family business. I started working there when I was about 14 years old 8 and I did everything from mopping floors, working the 9 counters, manning the register, doing deliveries. 10 Т worked there for 23 years, and in that time I grew to 11 12 appreciate the kindness and loyalty of the community, the value of hard work, and the ups and downs of 13 14 keeping the business afloat. I went on to 19 20 Pratt Institute where I earned my Bachelor's Degree in Architecture and graduated with honors. In 2001 I 21 2.2 began working for JLJ Kelly (sic) and their 23 architect. At the firm, I learned zoning and code 24 analysis, have regularly worked on projects with countless city agencies and closely followed zoning 25

Public service is also deeply 4 important in my family. My older brother who passed 5 away at the 34 was a New York City Police Officer 6 7 having worked nine years and the 39<sup>th</sup> Precinct in Bedford-Stuyvesant working midnight tours, and then 8 later as a sergeant out of the 43<sup>rd</sup> Precinct in the 9 Bronx. My passion for the community I live in took 10 the form of community board service. I applied in 11 12 2005 and was appointed by then the late Helen-the late Helen Marshall to Queens Community Board 9, 13 14 which covers the areas of Richmond Hill, Ozone Park, 15 Kew Gardens, and Woodhaven. I immediately joined the 16 Land Uwe Committee and served there ever since. Over my 13 years of experience on CB9 including three 17 18 years as Chair of the Board not only have I gained experience working closely on major land use matters 19 20 affecting our communities during that time, but also developed a deep appreciation for the importance of 21 2.2 conducting city business in a transparent, 23 respectful, consistent and open-minded manner both with fellow board members and with the public. These 24 are the values I will continue to uphold on the City 25

13	you all very much for considering my appointment.

16	hat are your thoughts on public-private partnerships

23	boards' point of view, I always thought it was

23	speaking from the Richmond Hill point of view from-
24	from what I saw in our last rezoning, we had Jamaica
25	Avenue, which was upzoned. It was a lower-it was a

2	C2-3 and R6B, and I'm sorry if I'm pulling out the
3	zoning, but to me I thought that it was great that it
4	was upzoned because it was a commercial thoroughfare

7	particular location was that at least the transit
8	system was there. So, it gave people an opportunity
9	if there was development within that area, people
10	would be able to use mass transit to get around, but
11	I think you have to approach every community
12	differently, take in regards to how the
13	infrastructure around them is, and, you know, and
14	you—you try to stay—you try—I would think you would
15	stay within the character of the community, and not
16	like, you know, just drop not a ridiculous zone, but
17	put a zone that does not apply to that area. So, I
18	mean I can go on all day. [laughs] I'm a little
19	nervous.
20	CHAIRPERSON KOSLOWITZ: Does anyone have
21	any questions? No questions. Margaret.
22	COUNCIL MEMBER CHIN: Good morning.
23	RAJ RAMPERSHAD: Good morning.
24	COUNCIL MEMBER CHIN: It's really good to
25	have a community board chair, and a-and also with

I just came from a hearing this morning at 3 the City Planning Commission fighting for my 4 community, and I was looking-I was reading some of 5 6 your-your response to the-the question. Can you 7 elaborate a little bit more on in terms of understanding the impacts on a community not just in 8 the immediate, but also in the future where there are 9 development decisions that are being made? 10 RAJ RAMPERSHAD: A great question. 11 You

12 know, speaking from a community board standpoint when 13 I saw our areas get rezoned Kew Gardens and in 14 Richmond Hill, it, you know, like for example they 15 took an area that was a lower density R4 or 5 and 16 made it R7. That was a big thing for developers because they started taking down one and two-family 17 18 houses and started building apartment houses. The parking got waived. So, the problem there was there 19 20 was not enough parking for the residents living there. But I think when you do major developments 21 2.2 like this there's a major impact and I-and I always 23 get concerned about the emergency services like the Police Department, Fire Department, Schools and, you 24 know, there's already a-I felt like the 25

So, whenever I see major 3 4 developments, I always think about that first what 5 kind of impact that's going to have that, and also as well as on the residents. So, for me, using Kew 6 7 Gardens as an example because there's a lot of development going on right there right now, and-we're 8 talking major developments of, you know, 10 families, 9 20 families even 30 family-unit apartment buildings 10 that where traditionally, it was one and two-family 11 12 And, you know, the residents-because I took homes. the brunt of it at the-at the community board 13 meetings, were very upset about it. They're building 14 15 out of the character of the neighborhood. Why did 16 you let this happen? And, you know, I would hope in the future that, you know, when rezonings are done 17 18 like this that the residents, the public their opinion gets weighed a little bit more in regards to 19 20 this and, you know, but in regards to when developments are happening, I do think about all 21 2.2 those, the effect it has on emergency services and 23 schools. 24 COUNCIL MEMBER CHIN: I-I think my other

question is what-that what we've been going through

3	thee technicalities, and one of the-the developments-

9	Planning decided it is a minor modification. So, it
10	doesn't have to go through ULURP. It doesn't have to
11	go through the community board. It doesn't have to
12	go through City Council, and that's where the debate
13	is right now. And so the borough president and I we
14	supported—we submitted a text amendment, and we
15	wanted to go through a ULURP because that would give
16	us a full review from the community board and the
17	City Planning Commission will also have their review,
18	and then it will come to the City Council. So, those
19	are the-I mean those are the technicality thing. Now
20	how would you see yourself in terms of being on a
21	Commission and really looking at those situation and
22	debating and making sure that-that the community does
23	get a full participation and not be eliminated
24	because of certain technicalities?

3	question because I was always concerned about ULURP
4	process. I believe in them because it does reach out
5	from the community board. It's supposed to trickle

7	found was whenever we would introduce that we had the
8	rezoning, that a lot of the residents that came to
9	our board meetings were not even informed. They
10	didn't know anything about it, and I felt-to me I
11	felt workshops are probably necessary to be done with
12	CPC and they recently did one at Queensborough Hall
13	for Land Use, which I thought was absolutely
14	fantastic for community board members to at least be
15	educated on the basic knowledge of how City Planning
16	operates. And I feel like these workshops should
