CHAIRPERSON MOYA: Good morning and welcome to the meeting of the Subcommittee on Zoning and Franchises. I'm Council Member Francisco Moya, the Chairperson of this Subcommittee, and today we are joined by Council Members Constantinides, Levin, Rivera, Torres, and Grodenchik. Today, we will vote to approve LU 312 an application heard by this subcommittee at the public hearing of January 20, 2019 by Carries Hospitality, LLC, Elder Greene for a revocable consent to maintain, operate and use an unenclosed sidewalk café at 160 Franklin Street in Council Member Levin's district in Brooklyn. We will be voting to approve this café, the size of which has been adjusted in response to community concerns.

COUNCIL MEMBER LEVIN: Thank you, Chair.

I appreciate the Land Use staff and the Land Use
Subcommittee working with my office on this issue.

This is—this was a—an application for a sidewalk café
at pre-existing sidewalk—the pre-existing business
establish had a sidewalk café, although in a
different configuration. The community organized

5	a solution that was not dictated by my office. They

8	Subcommittee and I-I urge my colleagues to vote aye.
