The project area consists of 17 two buildings located at 138 through 140 West 117<sup>th</sup> Street, Block 1901, Lots 51 and 52, and 264 West 18 117<sup>th</sup> Street Block 1922, Lot 53. The proposed 19 20 actions will facilitate the disposition and 21 rehabilitation of the properties as affordable 22 housing.
