2 (sound check) (pause) (gavel) 3 CHAIRPERSON DROMM: Okay, good morning, 4 and welcome to today's Finance Committee meeting. 5 I'm Council Member Daniel Dromm, and I'm Chair of the 6 Committee. We have been joined by Council Member 7 Francisco Moya, Council Member Karen Koslowitz, 8 Council Member Adrienne Adams, Council Member Alicka 9 Ampry-Samuel, Council Member Farah Louis, Council 10 Member Mark Gjonaj, Council Member Helen Rosenthal, 11 Council Member and Minority Leader Steve Matteo and 12 Council Member Barry Grodenchkik. Before I begin, 13 I'd like to give a warm welcome to Council Members 14 Ayala and Ampry-Samuel (cheers/applause) as the 15 newest members join the Finance Committee. Thank you, and we've now been joined by Council Member 16 17 Today the Committee will be voting on six Ayala. 18 items, which are Proposed Intro 245-B, an expense 19 budget modification, a revenue budget modification, 20 two resolutions to approve the Council's Fiscal 2021 21 Operating Budget and a transparency resolution, and 2.2 let's begin with the Proposed Intro 245-B. This bill 23 sponsored by Council Member Reynoso would require the 24 Department of Finance to: (1) Create a not-for-profit 25 ombudsperson position. (2) Exempt certain property

that received a not-for-profit tax exemption within 2 3 the prior two years from a tax lien sale. (3) Exempt 4 property from the tax lien sale where the owner has 5 in good faith submitted an application for the Notfor-Profit Property Tax Exemption with DOF. (4) 6 7 Provide notice to Class 4 property owners about 8 exemptions and other actions to remove a property 9 from the tax lien sale, and (5) Include information on how to remove a property from the tax lien sale 10 11 when denying applications for certain exemptions. New 12 York City is home to thousands of not-for-profit organizations that deliver critical programs and 13 14 services to communities throughout the five boroughs, 15 provide for our residents' spiritual and religious needs, and do countless hours of charitable work. 16 17 This bill is an important step towards ensuring that 18 they don't unintentionally end up in the lien sale to 19 provide them with necessary information and 20 assistance to help navigate some of the city's 21 bureaucratic processes. Next are two budget 2.2 modifications. The first modification is the Expense 23 Budget modification that represents movements of approximately \$749.2 million of funding between and 24 within the city agencies to implement Expense Budget 25

2	changes, which were included in the Fiscal 2020
3	Adopted Budget, and reflected in the city's January
4	Financial Plan. The second is a Revenue Budget
5	modification that recognizes \$677.6 million of new
6	revenues in the Fiscal 2019, and authorizes the
7	appropriation of that new revenue combined with \$400
8	million of prior year payables and \$850 million from
9	the General Reserve to increase the Budget
10	Stabilization Account by \$2.2 billion to pre-pay
11	Fiscal 2021 debt service. The fourth and fifth items
12	is the Council's Fiscal 2021 Operating Budget, which
13	totals \$90.4 million. This is divided into \$70.5
14	million for personnel services and \$19.9 million for
15	other than personnel services. Next is the
16	Transparency Resolution, which sets forth the new
17	designation and changes in the designation of certain
18	organizations receiving local and youth discretionary
19	funding and funding pursuant to certain initiatives
20	in the Budget. Organizations appearing in the
21	Resolution that have not yet completed their pre-
22	qualification process conducted by the Mayor's Office
23	of Contract Services, the Council or another entity
24	are identified in the attached charts with an
25	asterisk. As with all transparency resolutions,

2	Council Members will have to sign a disclosure form
3	indicating whether or not a conflict exists with any
4	of the groups on the attached list. If any council
5	member has a potential conflict of interest with any
6	of the organizations listed, he or she has the
7	opportunity to disclose the conflict at the time of
8	their vote. As a reminder, please disclose any
9	conflicts you may have with proposed subcontractors
10	used by organizations sponsored by discretionary
11	funding. These disclosures must be made before the
12	subcontractor can be approved. Benjamin Smith from
13	the General Counsel's Office is here, and can assist
14	you with any questions or concerns regarding
15	disclosures. So, those are all of today's items. Are
16	there any questions? Seeing none, I'm going to ask
17	the Billy Martin the ClerkCommittee Clerk to call
18	the roll.
