15 CHAIRPERSON DROMM: OKAY, I JUST WANT TO ASK 16 COUNSEL TO SEND ME THE LIST OF ALL OF ALL OF MY COLLEAGUES WHO ARE ON HERE. I DON'T THINK I HAVE 17 18 THAT YET. BUT ANYWAY, GOOD MORNING AND WELCOME TO 19 TODAY'S FINANCE COMMITTEE MEETING. I'M COUNCIL 20 MEMBER DANIEL DROMM, AND I CHAIR THE COMMITTEE. 21 I'LL INTRODUCE MY COLLEAGUES IN A MOMENT. TODAY 22 THE COMMITTEE WILL BE VOTING ON THREE ITEMS, ONE 23 ARTICLE XI PROPERTY TAX EXEMPTION, A TRANSPARENCY 24 RESOLUTION AND INTRO 2136, WHICH WOULD AUTHORIZE 25 TWO BIDS TO INCREASE THEIR ASSESSMENTS. FIRST, WE

2	HAVE THE LAND USE ITEM, 1402 YORK AVENUE IN COUNCIL
3	MEMBER KALLOS' DISTRICT. IT'S THE SITE OF A NEW
4	CONSTRUCTION AFFORDABLE HOUSING PROJECT CONSISTING
5	OF 11 UNITS OF, 10 OF WHICH WILL BE PERMANENTLY
6	AFFORDABLE. TODAY, UM, TODAY'S ACTION WOULD
7	PROVIDE A FULL 40-YEAR ARTICLE XI PROPERTY TAX
8	EXEMPTION TO SUPPORT THIS PROJECT. COUNCIL MEMBER
9	KALLOS IS SUPPORTIVE OF THE PROPOSED EXEMPTION.
10	SECOND, WE HAVE THE TRANSPARENCY RESOLUTION. THE
11	TRANSPARENCY RESOLUTION SETS FOR THE NEW
12	DESIGNATION AND CHANGES IN DESIGNATION OF CERTAIN
13	ORGANIZATIONS RECEIVING LOCAL AGING, ANTI-POVERTY
14	AND YOUTH DISCRETIONARY FUNDING AND FUNDING
15	PURSUANT TO CERTAIN INITIATIVES IN THE BUDGET. AS
16	WITH ALL TRANSPARENCY RESOLUTIONS, COUNCIL MEMBERS
17	WILL HAVE TO SIGN A DISCLOSURE FORM INDICATION
18	WHETHER OR NOT A CONFLICT EXISTS WITH ANY OF THE
19	GROUPS ON THE ATTACHED LIST. IF ANY COUNCIL MEMBER
20	EVER HAS A POTENTIAL CONFLICT OF INTEREST WITH ANY
21	OF THE ORGANIZATIONS LISTED, HE OR SHE HAS THE
22	OPPORTUNITY TO DISCLOSE THE CONFLICT AT THE TIME OF
23	THEIR VOTE. AS A REMINDER, PLEASE DISCLOSE ANY
24	CONFLICT YOU MAY HAVE WITH PROPOSED SUBCONTRACTORS
25	USED BY ORGANIZATIONS SPONSORED BY DISCRETIONARY

2	FUNDING. THESE DISCLOSURES MUST BE MADE BEFORE THE
3	SUBCONTRACTOR CAN BE APPROVED. DISCLOSURE FORMS
4	MUST BE COMPLETED AND SUBMITTED PRIOR TO THE VOTE
5	ON THE TRANSPARENCY RESOLUTION, AND MAY BE EMAILED
6	TO CHARLES DAVIS. FINALLY, WE HAVE INTRO 2136,
7	WHICH WOULD AUTHORIZE TWO BIDS TO INCREASE THE
8	AMOUNTS THEY WOULD SPEND ANNUALLY. THE COUNCIL
9	PREVIOUSLY APPROVED RESOLUTION 1471 ON OCTOBER 29TH
10	SETTING TODAY AS THE DATE FOR A PUBLIC HEARING ON
11	THIS LEGISLATION. THE BUDGET INCREASES HAVE BEEN
12	REQUESTED BY THE PROPERTY OWNERS WITHIN THE
13	BOUNDARIES OF EACH BID AND WOULD BE USED TO ENHANCE
14	THE SERVICES PROVIDED. THE DETAILS ABOUT WHICH BIDS
15	WOULD SEE INCREASES IN THE AMOUNT SOUGHT ARE SET
16	FORTH IN THE DOCUMENTS PREPARED BY THE FINANCE
17	STAFF. DEPUTY COMMISSIONER BLAISE BACKER FROM THE
18	DEPARTMENT OF SMALL BUSINESS SERVICES IS HERE TO
19	TESTIFY REGARDING THE REQUESTED ASSESSMENT
20	INCREASES AND WE'LL HEAR FROM HIM IN A MINUTE AFTER
21	HE IS SWORN IN BY COUNSEL, BUT LET ME INTRODUCE MY
22	COLLEAGUES BEFORE WE DO THAT. WE HAVE BEEN JOINED
23	BY COUNCIL MEMBER AND SUBCOMMITTEE CO-CHAIR VANESSA
24	GIBSON, COUNCIL MEMBERS CORNEGY CUMBO, MAJORITY
25	LEADER CUMBO, COUNCIL MEMBER ROSENTHAL, VAN BRAMER,

2	MOSKOWITZ AND, ADAMS, GRODENCHIK, AYALA, MOYA,
3	POWERS, LOUIS, AND MATTEO AND KOSLOWITZ. (LAUGHS)
4	OKAY AND BEAR WITH ME ONE MINUTE. OKAY AND COUNSEL,
5	WOULD YOU SWEAR IN, UM, MR. BACKER, PLEASE.
6	LEGAL COUNSEL: I WILL AND ALSO WE WERE JUST
7	JOINED BY COUNCIL MEMBER GJONAJ. UM, DO YOU AFFIRM
8	THAT YOUR TESTIMONY WILL BE TRUTHFUL TO THE BEST OF
9	YOUR KNOWLEDGE, INFORMATION AND BELIEF?
10	MR. BACKER: I DO.
11	LEGAL COUNSEL: THANK YOU. YOU MAY
12	PROCEED.
13	MR. BACKER: THANK YOU. GOOD MORNING
14	CHAIR DROMM, AND MEMBERS OF THE FINANCE COMMITTEE. SO
15	GOOD TO SEE SO MANY OF YOU ALL AT ONCE. I HOPE YOU'RE
16	ALL DOING WELL AND STAYING HEALTHY. I AM MICHAEL
17	BLAISE BACKER, DEPUTY COMMISSIONER FOR NEIGHBORHOOD
18	DEVELOPMENT AT THE DEPARTMENT OF SMALL BUSINESS
19	SERVICES, AND I WISH TO EXPRESS OUR SUPPORT FOR THE
20	LAW PROVIDING AN INCREASE IN THE AMOUNT TO BE
21	EXPENDED IN TWO BUSINESS IMPROVEMENT DISTRICTS OR
22	BIDS. TO PROPOSE AND ASSESSMENT INCREASE BIDS MUST
23	COMPLETE A MULTI-STEP REVIEW PROCESS OVERSEEN BY SBS,
24	THE BID BOARD OF DIRECTORS, WHICH INCLUDES PROPERTY
25	OWNERS, MERCHANTS AND RESIDENTS AS WELL AS
l	

2 REPRESENTATIVES FROM THE CITY COMPTROLLER, BOROUGH 3 PRESIDENTS, THE COUNCIL AND SBS, MUST PREVIEW AND 4 APPROVE THE PROPOSED ASSESSMENT INCREASE. 5 ADDITIONALLY, SBS REQUIRES ALL BIDS TO SUBMIT A FIVE-PART JUSTIFICATION OUTLINING HOW THE INCREASE WILL BE 6 7 ALLOCATED, MINUTES FROM THE BOARD MEETING WHEN THE 8 INCREASE WAS APPROVED AND LETTERS OF SUPPORT BY ALL 9 CITY COUNCIL MEMBERS REPRESENTED IN THE BID BOUNDARIES. SBS THEN REVIEWS THESE JUSTIFICATIONS 10 11 AND DETERMINES WHETHER THEY HAVE SUFFICIENT TO BRING 12 THE CITY COUNCIL. THIS YEAR SBS IS ALSO CONSIDERING THE IMPACTS OF THE COVID-19 PANDEMIC. THROUGHOUT THE 13 CITY BIDS HAVE BEEN CALLED UPON TO DELIVER AN 14 15 INCREASED LEVEL OF SERVICES AND SUPPORT TO THE SMALL 16 BUSINESS COMMUNITY REELING FROM THE PUBLIC HEALTH AND 17 ECONOMIC IMPACTS OF THE VIRUS. EVERY SINGLE DAY IT 18 HAS BEEN SCOURING THEIR BUDGETS FOR SAVING AND 19 EFFICIENCIES. MANY BIDS HAVE OPTED TO FOREGO 20 ASSESSMENT INCREASES THIS YEAR HAVING FOUND SUFFICIENT SAVINGS, BUT FOR SOME IT INCREASES 21 2.2 CRITICAL TO CONTINUING SERVICES AND SUPPORT DURING 23 THESE CHALLENGING TIMES. AS REQUIRED BY LAW, EACH OF THE TWO BIDS PUBLISHED A NOTICE OF THIS PUBLIC 24 25 HEARING AT LEAST ONCE IN THE LOCAL NEWSPAPER HAVING

2 GENERAL CIRCULATION IN THE DISTRICTS SPECIFYING THE 3 TIME AND PLACE OF TODAY'S HEARING AND STATING THE 4 PROPOSED THE AMOUNT TO BE EXPENDED ANNUALLY. EACH BID 5 HAS ALSO CERTIFIED THAT THEY HAVE MAILED A LETTER TO PROPERTY OWNERS INFORMING THEM ABOUT THE PROPOSED 6 7 ASSESSMENT INCREASE AND THE TIME AND PLACE OF THIS PUBLIC HEARING. IT IS A PRIORITY THAT SBS DOES 8 9 ASSESSMENT INCREASED PROPOSALS FOCUSED ON ENHANCING PROGRAMS AND SERVICES PROVIDED TO THE DISTRICT. THE 10 11 TWO BIDS PROPOSING ASSESSMENT INCREASES ARE DOING SO 12 TO ADDRESS VITAL NEEDS AND CHANGING CONDITIONS ON THE 13 GROUND. FOR EXAMPLE, BY IMPARTIAL OFFSET DECLINES AND PROGRAM REVENUES CAUSED BY THE EFFECT OF THE 14 15 COVID-19 OUTBREAK AND RECOVERY SPECIFICALLY CHANGING 16 THE CONFIGURATION OF STAFFING OF THE WINTER VILLAGE 17 TO ACCOMMODATE PROPER DISTANCING AND FOLLOWING ALL HEALTH GUIDANCE, ANTICIPATING LOWER VOLUME OF PARK 18 19 DEATHS AND SCALING DOWN BACK ON REVENUE GENERATING 20 PROGRAMS DUE TO THE OUTBREAK. FOR FLATBUSH NURSE INJUNCTION, THE INCREASE WILL PROVIDE THE BID WITH 21 2.2 MUCH NEEDED FUNDS TO STABILIZE SUPPLEMENTED 23 SANITATION SERVICES IN THE DISTRICT THEREBY RELIEVING FINANCIAL PRESSURE AND ALLOWING THE ORGANIZATION TO 24 25 DELIVER SERVICES THAT ARE MOST CRITICALLY NEEDED TO

2 SUPPORT THE COMMERCIAL CORRIDOR. IN ADDITION TO 3 INVESTMENTS IN SUPPLEMENTARY SANITATION, THIS 4 INCREASE WILL ALLOW THE BID TO PROVIDE PROGRAMMING ON 5 UNDER THE NEW (INAUDIBLE) PLAZA AND HIRE ADDITIONAL STAFF TO FURTHER PROMOTE THE DISTRICT. THE PROPOSED 6 7 INCREASES WROUGHT BY '21 RANGE FROM \$150,000 TO \$900,000 VARYING ACCORDING TO BUDGET SIZE, DISTRICT 8 9 SIZE AND PROPOSED CHANGES IN PROGRAMS AND SERVICES. THE PROPOSED INCREASES ARE FOR BRYANT PARK FOR ONE 10 11 \$1,600,000 TO \$2,500,000 AND FLAT BUSH, NELSON 12 JUNCTION FROM \$200,000 TO \$350,000. THE CITY'S 76 13 BIDS INVESTED OVER \$167 MILLION INTO NEIGHBORHOOD ECONOMIES IN THE FORM OF SUPPLEMENTAL SERVICES AND 14 15 PROGRAMS THAT SERVE MORE THAN 93,000 BUSINESSES 16 ACROSS THE CITY. BIDS HAVE BEEN VALUABLE IN IMPROVING 17 PARTNERS AND ONGOING INITIATIVES AND NEIGHBORHOOD 18 REVITALIZATION AND ECONOMIC DEVELOPMENT ACROSS THE 19 FIVE BOROUGHS MAKING NEW YORK CITY NEIGHBORHOODS 20 CLEANER, SAFER, MORE VIBRANT. BIDS ARE ALSO 21 ADVOCATES FOR SMALL BUSINESSES IN THEIR DISTRICTS 2.2 HELPING THEM TO NAVIGATE GOVERNMENT, FACILITATING 23 NETWORKING AMONG FELLOW BUSINESS OWNERS, PROVIDING BUSINESS RETENTION SUPPORT AND ATTRACTING SHOPPERS TO 24 THE AREA. CURRENTLY BIDS HAVE BEEN CRITICAL PARTNERS 25

2 IN EXECUTING THE CITY'S PANDEMIC RESPONSE. THEY HAVE 3 BEEN ADVOCATES FOR SMALL BUSINESSES BOOSTING 4 MARKETING EFFORTS AND PUSHING IN PROGRAMS FOR THOSE 5 BUSINESSES THAT ARE OPEN HAVING DISTRIBUTED PTE TO LOCAL STOREFRONT AND REMAINED AN REMAINED AN 6 7 IMPORTANT LIAISON BETWEEN GOVERNMENT AND THEIR 8 COMMERCIAL CORRIDORS AND DISTRIBUTING ACCURATE UP TO 9 DATE INFORMATION AND PROVIDED DIRECT TECHNICAL ASSISTANCE HELPING BUSINESSES APPLY FOR GRANTS AND 10 11 LOANS. THE PARTNERSHIP WITH CITY GOVERNMENT BIDS HELP 12 FOR JOB CREATION, IMPROVE THE QUALITY OF LIFE FOR NEW 13 YORKERS AND VISITORS, ENHANCE THE CITY'S TAX BASE AND 14 STRENGTHEN LOCAL ECONOMIES. REPRESENTATIVES FROM EACH 15 BID REQUESTING ASSESSMENT INCREASE ARE PRESENT TO 16 ANSWER ANY QUESTIONS PERTAINING TO THEIR SPECIFIC 17 REQUESTS, AND I AM HAPPY TO TAKE ANY QUESTIONS YOU 18 MAY HAVE NOW.
