I am writing to express serious concern with the plans to upzone the real estate plot located at 1620 Cortelyou Road in Brooklyn.

As I understand it, if a rezoning is allowed, a real estate developer will be granted the opportunity to construct a building completely out of character of the neighborhood, stretching 40+ feet higher than all the buildings in the nearby area. This particular block is essential to the neighborhood in terms of creating a welcoming, Main Street feel. Further, the grocery store there is an essential service for the thousands of people who live in the community. They need a good, accessible grocery store that is convenient to their daily lives. Redevelopment will be a great disruption to that.

I am well aware of the urgent need for affordable housing. I'm also well aware that New York City has a poor track record in creating truly affordable housing, especially for families.
