Dear Council Members:

In accordance with Section 107(b) of the New York City Charter, I request your approval to transfer City funds between various agencies in fiscal year 2021 to implement changes in the City's expense budget.

This modification (MN-3) will implement expense budget changes which were reflected in the City's January Financial Plan. In addition, as requested by the City Council, this modification reflects the following: funding for the reallocation of City Council initiatives that were included in the FY 2021 Adopted Budget as well as other discretionary programs and a transfer of Community Lien Sale Outreach funds from the Department of Finance to the Department of Housing Preservation and Development.

Appendix A details State, Federal and other funds impacted by these changes.

Your approval of modification MN-3 is respectfully requested.
