#### **New in the Executive Budget**



**Commercial Waste Zones.** The Fiscal 2022 Executive Plan includes \$3.96 million in Fiscal 2022, decreasing to \$3.66 million in Fiscal 2025 for commercial waste zones. Funding will support 38 positions, as well as temporary staffing, consultants, information technology, outreach and marketing, and office supplies.



**Organics Program.** The Fiscal 2022 Executive Plan includes \$30.5 million in Fiscal 2022 only for curbside organics collection, as well as Food Scrap Drop-Off sites (FSDOs). Of this funding, \$19 million will support curbside collection and FSDOs, \$7.5 million for collection in schools, and \$4 million for fall, leaf and yard collection.



**Precision Cleaning Initiative.** The Fiscal 2022 Executive Plan includes \$2.9 million in Fiscal 2022, decreasing to \$2.3 million in Fiscal 2025 for the Department's Precision Cleaning Initiative. The Precision Cleaning Initiative uses borough-based teams to conduct targeted cleanings of litter conditions, illegal dumping, and overflowing litter baskets. Teams will be dispatched based on DSNY field observations, 311 complaints and referrals from other City agencies and community groups.




Waste Export/Recycling Processing. The Fiscal 2022 Executive Plan includes \$33 million in Fiscal 2022, growing to \$56.9 million in Fiscal 2025 for waste export and recycling processing. Funding reflects an estimate of DSNY's contractual obligation costs for metal, glass, plastic processing, as well as for waste export.



**Special Waste Programs.** The Fiscal 2022 Executive Plan includes \$2.6 million in Fiscal 2022 for special waste programs. For Fiscal 2022, the Department will aim to have a special waste disposal pop-up event in each community board, as well re-open five special waste sites in each borough; sites will be open five days per month.
