The presence of a quorum was announced by the Majority Leader and Acting President Pro Tempore (Council Member Cumbo).

There were 50 Council Members marked present at this Stated Meeting held remotely.

At the time of this Stated Meeting, there was one vacant seat on the Council in the 37th District (Brooklyn).

#### 2. Invocation

The Invocation was delivered by Rabbi Sharon Kleinbaum, D.D., Senior Rabbi, serving as the spiritual leader of Beit Simchat Torah located at 130 West 30th Street, New York, N.Y. 10001.

The Speaker (Council Member Johnson) moved to spread the Invocation in full upon the Record.

At this point, Council Member Koslowitz made a motion to suspend certain Rules of the Council pursuant to Rule 10.20 in relation to certain emergency measures made in response to the public health risk posed by the Coronavirus pandemic. She noted that this suspension and amendment to the Rules of the Council would last only for the duration of the declared Coronavirus emergency by the Governor of New York State or the Mayor of New York City pursuant to New York Executive Law.

Council Member Koslowitz requested a suspension of the following Rules of the Council: 2.30, 5.10, 6.00, 6.30, 7.50(b) and (c), 7.70(a), 7.130, 8.40(a), and 11.60(a).

Council Member Koslowitz also declared that her motion would allow the Speaker to suspend any other Rule of the Council that would prevent he Council and its committees from conducting their regular business remotely, as long as that suspension is consistent with Federal, state and local law. To make such additional suspensions, she noted, the Speaker would need to publish the rules being suspended on the Council website.

As required by Rule 10.20, the Majority Leader and Acting President Pro Tempore (Council Member Cumbo) asked for unanimous consent to adopt CM Koslowitz's motion to suspend and amend certain Rules of the Council.
