INTRODUCTION AND READING OF BILLS

Res 1320-2020 Resolution calling upon the United States Department of Agriculture to expand the number of retailers that are permitted in the Supplemental Nutrition Assistance Program online purchasing program to ensure vulnerable communities in New York City can safely access healthy food.
