Be it enacted by the Council as follows:

Section 1. Section 26-520 of the administrative code of the city of New York, as amended by local law

number 113 for the year 2020, is amended to read as follows:

§ 26-520 Expiration date. This chapter shall expire on [April] July 1, 2022 unless rent control shall

sooner terminate as provided in subdivision three of section one of the local emergency housing rent control

law.

§ 2. This local law takes effect immediately.
