WHEREAS, the City Planning Commission filed with the Council on January 11, 2013 its decision dated January 9, 2013 (the "Decision") on the application submitted pursuant to Section 197-c of the New York City Charter by the New York City Department of Citywide Administrative Services (DCAS), for the disposition of city-owned property located in the JFK Industrial Business Zone, on the south side of 146<sup>th</sup> Avenue, between 153<sup>rd</sup> Court and 157<sup>th</sup> Street (Block 14260, part of Lot 1), pursuant to zoning (Application No. C 130023 PPQ), Community District 13, Borough of Queens (the "Application");
