WHEREAS, the New York City Department of Housing Preservation and Development ("HPD") submitted to the Council on September 18, 2008 its request dated September 8, 2008 that the Council take the following actions regarding an Urban Development Action Area Project (the "Project") located at 142-05 Rockaway Boulevard (Block 12036, Lot 99), Community District 12, Borough of Queens (the "Disposition Area"):

- 1. Find that the present status of the Disposition Area tends to impair or arrest the sound growth and development of the municipality and that the proposed Urban Development Action Area Project is consistent with the policy and purposes of Section 691 of the General Municipal Law;
- 2. Waive the area designation requirement of Section 693 of the General Municipal Law pursuant to said Section;
- 3. Waive the requirements of Sections 197-c and 197-d of the New York City Charter pursuant to Section 694 of the General Municipal Law; and

4. Approve the Project as an Urban Development Action Area Project pursuant to Section 694 of the General Municipal Law.

WHEREAS, by submission dated February 9, 2009, the Department of Housing Preservation and Development withdrew the application.
