A Local Law to amend the administrative code of the city of New York, in relation to prohibiting the department of sanitation from charging the New York city housing authority for sanitation services

## Be it enacted by the Council as follows:

Section 1. Section 16-114 of the administrative code of the city of New York, as amended by local law number 41 for the year 1992, is amended to read as follows:

§ 16-114 Rates for collection and disposal. <u>a.</u> The commissioner may charge for the collection and disposal of ashes, street sweepings, garbage, refuse, rubbish, dead animals, night soil and offal, and all wastes,

including trade waste from business, industrial, manufacturing, or other establishments conducted for profit, at

rates established by the council by local law, upon recommendation of the commissioner, and on such terms

and conditions as the commissioner shall prescribe and subject to rules of the department governing such

collection and disposal.

b. Notwithstanding subdivision a of this section and notwithstanding any memorandum of

understanding or other agreement to the contrary, the commissioner shall not charge the New York city housing

authority for the collection and disposal of solid waste or any other sanitation service provided by the

department to a project operated by such authority.

§ 2. This local law takes effect July 1 of the year succeeding the year in which it becomes law.
