WHEREAS, the Landmarks Preservation Commission filed with the Council on November 25, 2009 a copy of its designation dated November 17, 2009 (the "Designation"), of the 145 Eighth Avenue House, located at 145 Eighth Avenue, Community District 4, Borough of Manhattan, as a landmark and Tax Map Block 741, Lot 31, as its landmark site pursuant to Section 3020 of the New York City Charter;
