**Whereas,** Bills have been introduced in the New York State Legislature by Senator Gounardes, S.6981-B, and Assembly Member Abbate, A.7971A, “AN ACT to amend the retirement and social security law, in relation to additional member contributions for certain members under the age fifty-seven retirement program”; and

**Whereas**, The enactment of the above State Legislation requires the concurrence of the Council of the City of New York as the local legislative body; now, therefore, be it
