Whereas, bills have been introduced in the New York State Legislature by Senators Golden and Spano, S.5150, and Assembly Member Abbate, A.7618-A, "AN ACT to amend the administrative code of the city of New York, in relation to the establishment of a twenty year retirement program for members of the New York city employees' retirement system employed as fire alarm dispatchers; and to amend the retirement and social security law, in relation to the establishment of twenty year retirement programs for such members who are subject to articles 11 and 15 of such law"; and
