A Local Law to amend the administrative code of the city of New York, in relation to status updates on contracts funded pursuant to discretionary appropriations

## Be it enacted by the Council as follows:

Section 1. The administrative code of the city of New York is amended by adding a new section 6-142

to read as follows:

§6-142 Reporting on discretionary funded contracts. The city chief procurement officer shall issue, upon request of a council member, a report to such council member within five days of such request with the status of contracts funded pursuant to discretionary appropriations of such council member. Such report shall be disaggregated by fiscal year and contracting agency and shall contain, for each applicable contract: (a) the total amount of funds allocated in the fiscal year by the contracted entity for the provision of services under the contract and (b) the total amount of funds reimbursed to the contracted entity in the fiscal year by the

## contracting agency for the provision of services under the contract.

§2. This local law takes effect immediately.
