A Local Law to amend the administrative code of the city of New York, in relation to the suspension of alternate side of the street parking rules on streets within a five block radius of street resurfacing projects

Be it enacted by the Council as follows:

Section 1. Subchapter 2 of chapter 1 of title 19 of the administrative code of the city of New York is

amended by adding a new section 19-163.3 to read as follows:

§ 19-163.3 Suspension of parking rules on blocks adjacent to street resurfacing projects.

Notwithstanding any other provision of law to the contrary, on days where the department is engaged in street

milling or resurfacing work, and has consequently used available parking spaces on streets where alternate side

of the street parking rules permit parking, such rules shall be suspended within a five block radius of any point along the work site in which parking spaces are being used by the department. The department shall post signage at prominent locations within the designated area indicating that such rules have been suspended.

§2. This local law takes effect immediately.
