WHEREAS, the Department of Consumer Affairs filed with the Council on November 2, 2018 its approval dated October 31, 2018 of the petition of T&S Restaurant, LLC, d/b/a Gracie's on 2<sup>nd</sup> Diner, for a renewal revocable consent to continue, maintain and operate an enclosed sidewalk café located at 300 East 86<sup>th</sup> Street, Community District 8, Borough of Manhattan (the "Petition"), pursuant to Section 20-225 of the New York City Administrative Code (the "Administrative Code");

WHEREAS, the Petition is subject to review by the Council pursuant to Section 20-225(f) of the Administrative Code;
