WHEREAS, the Department of Consumer Affairs filed with the Council on November 2, 2018 its approval dated October 31, 2018 of the petition of K.K. & D. of 79<sup>th</sup> Street, Restaurant Corp. d/b/a Nectar Cafe, for a renewal revocable consent to continue, maintain and operate an unenclosed sidewalk café located at 1022 Madison Avenue, Community District 8, Borough of Manhattan (the "Petition"), pursuant to Section 20-226 of the New York City Administrative Code (the "Administrative Code");

WHEREAS, the Petition is subject to review by the Council pursuant to Section 20-226(f) of the Administrative Code;
