Int. No. 1533-A

By The Public Advocate (Mr. Williams) and Council Members Menchaca, Ayala, Kallos, Perkins and Rivera

A Local Law to amend the New York city building code, in relation to the definition of site safety training full compliance date and site safety training second compliance date

Be it enacted by the Council as follows:

Section 1. The definitions of "SITE SAFETY TRAINING (SST) FULL COMPLIANCE DATE" and

"SITE SAFETY TRAINING (SST) SECOND COMPLIANCE DATE" in section 3302.1 of the New York city

building code, as added by local law number 196 for the year 2017, are amended to read as follows:

SITE SAFETY TRAINING (SST) FULL COMPLIANCE DATE. [Five months after the SST second compliance date, or, if the department publishes a finding that there is insufficient capacity to provide the training required by Section 3321 of the New York city building code to the workers who would need such training, a later date established by the department, provided that such date is not later than] September 1, 2020.

SITE SAFETY TRAINING (SST) SECOND COMPLIANCE DATE. December 1, <u>2019</u> [2018], or, if the department publishes a finding <u>by September 1, 2019</u> that there is insufficient capacity to provide the training required by Section 3321 of the New York city building code to the workers who would need such training, a later date established by the department, provided that such date is not later than June 1, [2019] <u>2020</u>.

§ 2. This local law takes effect immediately.
