A Local Law to amend the administrative code of the city of New York, to repeal subchapter 19 of chapter 5 of title 20, in relation to the prohibition of conversion therapy services

Section 1. Subchapter 19 of chapter 5 of title 20 of the administrative code of the city of New York is
REPEALED.

§ 2. This local law takes effect immediately and is retroactive to and deemed to have been in effect as of
September 12, 2019.
