### THE COUNCIL OF THE CITY OF NEW YORK RESOLUTION NO. 1270

**Resolution approving the site plan for a new, approximately 322-Seat Primary School Facility, located at 6740 3<sup>rd</sup> Avenue (Block 5853, Lot 45), Community District 10, Borough of Brooklyn (Non-ULURP No. 20205150 SCK; L.U. No. 615).**

WHEREAS, the New York City School Construction Authority submitted to the Council on November 7, 2019, a site plan pursuant to Section 1732 of the New York State Public Authorities Law for a new, approximately 322-Seat Primary School Facility, located at 6740 3<sup>rd</sup> Avenue (Block 5853, Lot 45), Community District 10, Borough of Brooklyn to accommodate students in Community School District No. 20 (the “Site Plan”);

WHEREAS, the Site Plan is subject to review and action by the Council pursuant to Section 1732 of the New York State Public Authorities Law;

WHEREAS, upon due notice, the Council held a public hearing on the Site Plan on February 12, 2020;

WHEREAS, the Council has considered the relevant environmental issues, including the negative declaration issued on January 9, 2020, (SEQR Project Number 20-006) (the “Negative Declaration”); and

WHEREAS, the Council has considered the land use implications and other policy issues relating to the

Site Plan.

RESOLVED:

The Council finds that the action described herein will have no significant effect on the environment as set forth in the Negative Declaration.

Pursuant to Section 1732 of the Public Authorities Law, the Council approves the Site Plan.
