Int. No. 2462

Be it enacted by the Council as follows:

Section 1. The following park name, in the Borough of Queens, is hereby renamed as hereafter indicated.

New Name	Present Name	Limits
Archie Spigner Park	St. Albans Park	An existing park area generally bounded by 169 Street, Sayres
		Avenue, Linden Boulevard, Marne Place, 111 Road and 172 Street

§2. The official map of the city of New York shall be amended in accordance with the provisions of

section one of this local law.

§3. This local law shall take effect immediately.
