### Proposed Int. No. 87-A

By the Public Advocate (Mr. Williams) and Council Member Louis

A Local Law to amend the administrative code of the city of New York, in relation to increasing the number of violations required to revoke authorization to operate a commuter van service

Be it enacted by the Council as follows:

Section 1. Paragraph (4) of subdivision a of section 19-504.4 of the administrative code of the city of

New York, as amended by local law number 41 for the year 2019, is amended to read as follows:

(4) Where [three] six or more violations of paragraph five of subdivision a of section 19-504.3

Provided, however, that such authorization shall be suspended for 15 days where [two] three violations of paragraph five of subdivision a of section 19-504.3

six-month period after the holder of such authorization has had an opportunity for a hearing in accordance with procedures to be established by the commission.

§ 2. This local law takes effect 120 days after it becomes law, and only applies with respect to a violation that occurs after the date that this local law takes effect.
