WHEREAS, the Landmarks Preservation Commission filed with the Council on November 2, 2009 a copy of its designation dated October 20, 2009 (the "Designation"), of the Herman A. and Malvina Schleicher House located at 11-41 123rd Street, Community District 7, Borough of Queens, as an historic landmark and Block 3997, Lot 40 as its landmark site pursuant to Section 3020 of the New York City Charter;

WHEREAS, the Designation is subject to review by the Council pursuant to Section 3020 of the City Charter;

WHEREAS, the City Planning Commission submitted to the Council on December 3, 2009 its report on the Designation dated December 2, 2009 (the "Report");
