**State Legislation Resolution requesting the New York State Legislature to pass bills introduced by Senator Gounardes, S.6981-B, and Assembly Member Abbate, A.7971A, "AN ACT to amend the retirement and social security law, in relation to additional member contributions for certain members under the age fifty-seven retirement program".**

**Whereas,** Bills have been introduced in the New York State Legislature by Senator Gounardes, S.6981-B, and Assembly Member Abbate, A.7971A, "AN ACT to amend the retirement and social security law, in relation to additional member contributions for certain members under the age fifty-seven retirement program"; and

**Whereas,** The enactment of the above State Legislation requires the concurrence of the Council of the City of New York as the local legislative body; now, therefore, be it

**Resolved,** That the Council of the City of New York, in accordance with the provisions of Section 2 of Article 9 of the Constitution of the State of New York, does hereby request the New York State Legislature to enact into law the aforesaid pending bills.
