Whereas, Bills have been introduced in the New York State Legislature by Senator Gounardes, S.6988-B, and Assembly Member Abbate, A.7962A, "AN ACT to amend the retirement and social security law and the

administrative code of the city of New York, in relation to the establishment of twenty-five year retirement programs for members of the New York city employees' retirement system employed as fire protection inspectors and associate fire protection inspectors”; and

Whereas, The enactment of the above State Legislation requires the concurrence of the Council of the City of New York as the local legislative body; now, therefore, be it
