Whereas, Bills have been introduced in the New York State Legislature by Senator Senator Jackson, S.6416, and Assembly Member Pheffer Amato, A.6750, "AN ACT to amend the administrative code of the city

of New York and the retirement and social security law, in relation to permitting certain New York city correction members to borrow from their accumulated member contributions; and to repeal certain provisions of the retirement and social security law relating thereto”; *and*
